NOTIFICATION-I

An Ordinance further to amend the Karnataka Legislature Salaries, Pensions and Allowances-Act, 1956.

Whereas the Karnataka Legislative Assembly is not in session and the Governor of Karnataka is satisfied that circumstances exist which render it necessary for him to take immediate action further to amend the Karnataka Legislature Salaries, Pensions and Allowances Act, 1956 (Karnataka Act 2 of 1957) for the purposes hereinafter appearing;

Now, therefore, in exercise of the powers conferred on me by clause (1) of Article 213 of the Constitution of India, I, A. N. Banerji, Governor of Karnataka, am pleased to promulgate the following Ordinance, namely:—

- 1. Short title and Commencement—(1) This Ordinance may be called the Karnataka-Legislature Salaries, Pensions and Allowances (Amendment) Ordinance, 1984.
 - (2) It shall come into force at once.
- 2. Amendment of section 15.—In section 15 of the Karnataka Legislature Salaries, Pensions and Allowances Act, 1956, (Karnataka Act 2 of 1957), after sub-section (2), the following sub-section shall be inserted, namely:—
- "(3) Notwithstanding anything contained in this Act, any other law, rule or order, all Rules, Notifications and Orders under this Act, relating to the Legislators, the Chairman, the Deputy Chairman, the Speaker, the Deputy Speaker, the Leaders of the Opposition and the Government Chief Whips in respect of their salary, allowances, pensions, medical bills, accommodation, personal staff, journeys, facilities of all types and the like, shall be issued by the Secretary, Karnataka Legislature with the approval of the Special Board, consisting of the Chairman, the Speaker, the Chief Minister and the Minister in charge of Parliamentary Affairs and in consultation with the Finance Department wherever necessary and not by the Government".

Notification-II dated 29th September 1984

No. LAW 67 LGR 79. In exercise of the powers conferred by Clause (3) of Article 187 and Clause (3) of Article 320 of the Constitution of India, the Governor of Karnataka after consultation with the Chairman, Legislative Council, and the Specaker, Legislative Assambly, hereby makes the following rules further to amend the Karnataka Legislature Secretariat (Recruitment and Conditions of Service) Rules, 1959, namely:

- 1. Title and commencement.—(1) These rules may be called the Karnataka Legislature Sepretariat (Recruitment and Conditions of Service) (Amendment) Rules, 1984.
 - (2) They shall come into force at once.
- 2. Amendment of Rule 2.—In sub-rule (1) of rule 2 of the Karnataka Legislature Secretariat (Recruitment and Conditions of Service) Rules, 1959 (hereinafter referred to as the said rules)—

(1) after clause (f) the following clause shall be inserted, namely:—

- "(fs) "Legislature Secretariat" means the Legislature Secre-
 - (2) after the clause (i), the following clause shall be inserted i-
 - Chief Minister, the Chairman, Legislative Council, the Speaker, Legislative Assembly and the Minister in charge of Parliamentary Affairs."

3. Amendment of Rule 3. Rule 3 of the said Rules shall be renumbered as sub-rule (1) thereof, and-

(1) in sub-rule (1) as so renumbered,-

(a) after the words "which shall" the following words shall be

inserted, namely :_

- 'include the Legislators' Home of the Karnataka State and the personal staff of the Chairman, the Deputy Chairman, the Speaker, the Deputy Speaker, the Leaders of Opposition in the Legislative Assembly and the Legislative Council and the Government Chief Whips in the Legislative Assembly and the Legislative Council and shall' and
- (b) for the words and figures "Classes I. II, III and IV" the words and letters Groups A, B, C and D" shall be substituted;

(2) after sub-rule (1) as so renumbered, the following sub-rules

shall be inserted, namely:---

- "(2) The Special Board may, by order, amend Schedule I by increasing or reducing the number of posts specified therein or by adding thereto any new category of post or posts or in any other manner".
- (3) "No order creating a post shall be made under sub-rule (2) except after consultation with the Finance Department."
- (4) "A copy of every order made under this rule shall be sent to the Secretary to Government in the Finance Department."

4. Amendment of rule 8.—In rule 8 of the said rules—

(1) in sub-rule (1), for the words and figures "Classes I and II shall be made by the Governor in consultation with the Commission and the Board" the words and letter "Group A and B shall be made by the Special Board" shall be substituted and for the words "Board" the words "Special Board" shall be substituted;

(2) in sub-rule (2), for the word and figures "Class III"

the word and letter "Group C" shall be substituted.

(3) in sub-rule (3) for the word and figures "Class IV" the word and letter "Group D" shall be substituted,

(4) for sub-rule (5), the following sub-rule shall be substi-

tated, namely:-

- "(5) Except as provided in these rules it shall not be necessary to consult the Government or the Commission on any matter, relating to the staff of the Karnataka State Legislature."
 - 5. Amendment of rule 8B.—In rule 8B of the said rules,

(1) sub-rule (1) shall be omitted;

- (2) in sub-rule (2), for the word and figures "Class III" the words and letters "Group B and Group C" shall be substituted.
- 6. Amendment of rule 8C.—In rule 8C of the said rules, in sub-rule (4), for the word and figures "Class IV" the word and letter "Group D" shall be substituted.
- 7. Amendment of rule 10.—In rule 10 of the said rules, in sub-rule (1);—

- tuted, namely:
 - (a) the Karnataka Government Servants' (Seniority) Rules
 - (b) The Karnataka Government Servants' (Conduct) Rules, 1957:
 - (c) The Karnataka Civil Services Rules, 1958;
 - (d) The Karnataka Financial Code, 1958;
 - (e) The Manual of Contingent Expenditure 1958;
 - (f) The Karnataka Government Servants (Medical), Attendance Rules, 1963:
 - (g) The Karnataka Recruitment of Gazetted probationers, (Appointment by Competitive Examinations) Rules, 1966;
 - (h) The Karnataka Civil Services (Direct Recruitment by .)
 Selection) Rules, 1973;
 - (i) The Karnataka Civil Services (Confidential Reports)
 - (j) The Karnataka Civil Services (General Recruitment) Release
- (k) The Karnataka Civil Services (Prebation) Rules, 1977; 4 6; for the time being in force."
- (2) for the first proviso, the following provises shall be substinged tuted namely:

Provided that the Board may exercise the powers of the State Sovernment under the provisions of the rules referred to in clauses (a) to (k) and the approval of the Governor shall be obtained where-evernecessary;

Provided further that wherever relaxation of the above said rules is necessary it shall be made in consultation with the Finance Department and with the approval of the Special Board;

Provided also that a copy of every order made by the Secretary to Government in the Finance Department."

(8) in the second proviso, for the words "Provided that" "Gazetted/Non-Gazetted staff" and "Gazetted Officers" the words "Provided also that", "Groups A to D" and "Groups A and B" shalf respectively be substituted.

8. Insertion of rule 11A to 11D. After rule 11 of the said rules, the following rules shall be inserted, namely :-

"11A. Any decision of the Board or the Special Board requiring the approval of the Governor under these rules or otherwise and be every proposal to make rules regulating the recruitment and conditions of service of the staff of the Legislature Secretariat under Article 187 of the Constitution of India shall be sent to the Governor for Approval, by the Secretary.

erder, provide for the convenient and efficient transaction of business arising out of the administration of these rules and the precedure to be followed for the purpose.

11D. No proposal baying financial implications shall be issued without the approval of the Special Board and such matters shall be pisced before the Special Board by the Secretary along with the semarks of the Finance Department".

9. Amendment of schedule I.— In Schedule I to the said rules, for the words and figures "Class I", "Class II", "Class III" and "Class IV" the words and letters "Group A", "Group B," "Group C" and "Group D" shall respectively be substituted.

10. Amendment of Schedule II.—In Schedule II to the said rules, in the entries relating to the category of posts of Research Assistants the word "Master's" shall be and shall be deemed always to have been omitted.

- 11 Amendment of Schedule LIL .- In Schedule LII to the said rules.-
 - (1) in the entries relating to Sl. No. 1,-
 - (a) in the entries in column 2 after the word "Secretary" the words "Additional Secretary" shall be insected.
 - (b) in the entries in solumn 3, for the word "Governor" the words "Special Board" shall be substituted.
 - (4) in the entries relating to St. No. 2, in the entries in column 3, for the words "Governor" the words "Special Board" shall be substituted.

Sub: Independent status of the Karnataka Legislature Secretariat -- regarding-

GOVERNMENT ORDER No. LAW 67 LGR 79, BANGALORE, DATED 29TH SEPTEMBER 1984.

READ

Correspondence resting with D.O. Letter No. 474/LA dated 23rd April, 1984, from the Secretary, Karnataka Legislature, Bangalore.

PREAMBLE:

The proposal regarding giving independent status to the Karnatika Legislature Secretariat was under consideration of the Government since 1945. The matter has been considered in detail and it has been decided to make the Legislature Secretariat independent in all respects which hither-to functioned through Government of Karnataka in the Department of Law and Parliamentary Affairs.

ORDER

Considering all aspects of the matter. Government of Karnataka heresy directs as follows:

- 1. The Secretary, Karnataka Legislature Secretariat, shall have the powers, privileges and status of a Secretary to Government in the Government Secretariat.
- 2. The service conditions, pay, dearness allowance, travelling allowance and other allowances, leave, pension, gratuity and other benefits and amenities etc., of the staff working in the Karnataka Legislature Secretariat shall be the same as that of other staff working in the Government Secretariat. Orders is sued by the Government in regard to these matters shall automatically stand extended to Legislature Secretariat without consulting the Government. If there is any modification involving financial implications, the same would be issued under the orders of Special Board after consulting the Government in Finance Department.
- 3. The pay scales of Karnataka Legislature Secretariat staff including the Secretary will come under the purview of the State Pay Commission, whenever one is appearanced. The Government will forward the recommendations of the Pay Commission relating to the Legislature Secretariat together with the orders of Government relating to Government Secretariat, to the Board and orders will be issued from the Legislature Secretariat based on the orders issued by the Government. The effect of such orders shall be from the same date as that for the employees of the Government Secretariat.

4. All orders, including financial sanctions, issued by the Karnataka Legislature Secretariat shall be expressed to be issued in the name of the Governor/Special Board/Board, as the case may be.

5. The Governor/Special Board/Board can delegate his/its powers to the Secretary and in such cases the orders shall be issued in the name of the

Governor/Special Board/Board.

6. All orders of the Governor/Special Board/Board shall be authenticated by the Secretary/Additional Secretary/Deputy Secretary / Under Secretary, Karnataka Legislature Secretariat under clause (2) of Article 166 of the Constitution as under:

"By order and in the name of the Board/ Special Board/Governor of Karnataka.

Signature.

Name and Designation of the Officer authorised to sign".

7. The Budget Estimates of the Karnataka Legislature Secretariat as approved by the Board shall be forwarded to the Finance Department for incorporation in the State Budget after mutual consultation between Finance Department and Legislature Secretariat. If there is any difference of opinion between the Finance Department and the Legislature Secretariat which could not be so settled it shall be resolved by mutual discussion by the Board and the Finace Minister. Even after this if the difference of opinion could not be resolved, it shall be settled in consultation with the Chief Minister.

8. All Financial sanctions within the budget provision shall be issued by

the Secretary, Karnataka Legislature Secretariat.

9. Rules (including amendments to the existing rules) order, Notifications and the like under the Legislature Salaries, Pensions, and Allowances Act, 1956 and all orders relating to the Legislature, Legislators, Presiding Officers, the Leaders of the Opposition and the Government Chief Whips, in respect of their salary, all types of allowances, pensions, medical bills, accommodation, personal staff, journeys, facilities and all orders relating to them shall be issued by the Secretary, Legislature Secretariat with the approval of the Special Board and in consultation with the Finance Department wherever necessary.

10. No Order having financial implications shall be issued without the approval of the Special Board and all such proposals shall be placed before the Special Board by the Secretary. Legislature with the remarks of the Government

in the Finance Department.

11. Necessary amendments to the laws. Government Business Rules and Secretariat instructions, will be issued by the concerned department in consultation with the Karnataka Legislature Secretariat.

12. Necessary amendments, if any, to the Karnataka Legislature Secretariat (Recruitment and Conditions of Service) Rules, 1959 will be issued by the

Karnataka Legislature Secretariat.

This Order issues with the concurrence of Finance Department and Department of Personnel and Administrative Reforms vide their U.O. Notes No. 2 D 784/Exp-II 84 dated 5-6-84 and No. D P A R 1560 S R A 84 dated 23-6-84.

Note: In this Order 'Special Board' means the Chairman, Legislative Council, the Speaker, Legislative Assembly, the Chief Minister and the Minister in charge of Parliamentary Affairs.

PREAMBLE:

The tree or a party

In Govt. order read at (1) above, independent status was conferred on the KLS in all respects by the Government.

In order read at (2) above, the Special Board of
Karnataka Legislature has accorded its approval for
bifurcation of the combined independent Secretariat of
Karnataka Legislature into two independent and separate
Secretariats for Legislative Assembly and Legislative Council
and the said Secretariats are designated as Karnataka
Legislative Assembly Secretariat and Karnataka Legislative
Council Secretariat respectively.

Consequent on the bifurcation of Karnataka Legislature
Secretariat into two independent separate Secretariats for
Karnataka Legislative Assembly and Karnataka Legislative Council

the order read at (1) above has to be modified suitably for its application to the respective Secretariat of Legislative Assembly and Legislative Council.

ORDER NO.ADM-I/95/KLS/97, BANGALORE- DATED 14TH AUGUST 1997.

Considering all aspects of the matter, the Special Board of Karnataka Legislature hereby makes the following order:-

- 1. The Secretaries of KLA and KLC Secretariats shall have the powers, privileges and status of a Secretary to Government in the Government Secretariat.
- 2. The service conditions, pay, dearness allowance, travelling allowance and other allowances, leave pension, gratuity and other benefits and amenities etc., of the staff working in the KLA and KLC Secretariats shall be the same as that of other staff working in the Government Secretariat. Orders issued by the Government in regard to these matters shall automatically stand extended to the respective Secretariats without consulting the Government. If there is any modification involving financial implications the same would be issued under the orders of Special Board of the respective Secretariats after consulting the Government in Finance Department.

- Karnataka Legislative Council Secretariats staff including the Secretaries will come under the purview of the State pay Commission, whenever one is appointed. The Government will forward the recommendations of the pay Commission relating to the KLA and KLC Secretariats together with the orders of Government relating to Government Secretariat, to the Hon'ble Speaker/Hon'ble Chairman, as the case may be, and orders will be issued from the KLA and KLC Secretariats based on the orders issued by the Government. The effect of such orders shall be from the same date as that for the employees of the Government Secretariat.
- 4. All orders, including financial sanctions, issued by the Karnataka Legislative Assembly and Karnataka Legislative Council Secretariats shall be expressed to be issued in the name of the Speaker/Chairman/Governor/Special Board, as the case may be.
- 5. All orders of the Speaker/Chairman/Special Board/Governor shall be authenticated by the Secretary/Additional Secretary/Joint Secretary/Deputy Secretary/Under Secretary, Karnataka Legislative Assembly and Karnataka Legislative Council Secretariats under clause (2) of Article 166 of the Constitution as under:
 - "By order and in the name of the Speaker/ Chairman/Special Board/Governor of Karnataka.

Signature,
Name and Designation of the officer,
authorised to sign"

- and Karnataka Legislative Council Secretariats as approved by the Speaker/Chairman, as the case may be, shall be forwarded to the Finance Department for incorporation in the State Budget after mutual consultation between Finance Department and KLA and KLC Secretariats. If there is any difference of opinion between the Finance Department and the KLA and KLC Secretariats which could not be so settled it shall be resolved by mutual discussion by the Speaker/Chairman, as the mase may be, and the Finance Minister. Even after this if the difference of opinion sould not be resolved, it shall be settled in consultation with the Chief Minister.
- 7. All Financial sanctions/within the budget provision shall issued by the Secretary, Karnataka Legislative Assembly Secretariat and Karnataka Legislative Council Secretariat, as the case may be.
- 8. Rules (including amendements to the existing rules) order, notifications and the like under the Legislature Salaries, pendon and Allowances Act, 1956 and all orders relating to the Legislature, Legislators, presiding officers, the Leader of the Opposition and the Government Chief Whips in respect of their salary, all types of allowances, pensions, medical bills accommodation, personal staff, journeys, facilities etc. shall issued by the Secretary, KLA and KLC Secretariats with the approx of the Special Board of the respective Secretariats and in consultation with the Finance Department, wherever necessary.

- 9. No order having financial implications shall be issued without the approval of the Special Board of the respective Secretariats and all such proposals shall be placed before the respective Special Board by the Secretary, KLA/KLC, as the case may be, with the remarks of the Government in the Finance Department.
- 10. Necessary amendments to the laws, Government Business Rules and Secretariat instructions will be issued by the concerned departments in consultation with the KLA and KLC Secretariats, as the case may be.
- 11. Necessary amendments, if any, to the KLA and KLC Secretariats (Recruitment and Conditions of Service) Rules, 1992 will be issued by the respective Secretariats of KLA and KLC Secretariats respectively.

Note: In this order 'Special Board' means the Speaker, Legislative Assembly, the Chief Minister and the Minister incharge of Parliamentary Affairs, in the case of KLA Secretariat; and the Chairman, LC, the Chief Minister and the Minister in charge of Parliamentary affairs in the case of KLC Secretariat.

Sub: Bifurcation of KLS into two independent Secretariats for L.A. & L.C.

Read: Govt: Order No.LAW 67 LGR 79, dated: 29.09.1984.

Preamble:

In Govt. Order read above independent status was granted to the Karnataka Legislature Secretariat in all respects. Accordingly, a common independent Secretariat for both the Houses of Legislature has been functioning and the administrative control of the Legislature Secretariat vested in the Board consisting of the Hon'ble Chairman, L.C. and the Hon'ble Speaker, L.A.

The Board desired that in terms of the provisions of Article 187 of the Constitution of India, there shall be a separate and independent Secretariat for each House of the Legislature and the existing combined Karnataka Legislature Secretariat shall be bifurcated into two independent Secretariat to be called as "Karnataka Legislative Assembly Secretariat" and "Karnataka Legislative Council Secretariat" and the administrative control of the respective Secretariats shall vest with Hon'ble Speaker and the Hon'ble Chairman respectively, on the pattern of

independent Secretariats functioning in the Parliament and State Legislatures of Bihar and Uttar Pradesh.

Accordingly, the proposal to bifurcate the existing combined Karnataka Legislature Secretariat into two independent Secretariats for the Karnataka Legislative Assembly and Karnataka Legislative Council was submitted for consideration and approval of the Special Board of Karnataka Legislature.

ORDER NO.ADM-I/95/KLS/97,
Bangalore, DATED LATH AUGUST 1997.

Considering all aspects of the matter, the Special
Board of Karnataka Legislature hereby accords its approval
for bifurcation of the existing combined Karnataka Legislature
Secretariat into two separate and independent Secretariats
for Legislative Assembly and Legislative Council to be
called hereafter as "Karnataka Legislative Assembly Secretariat"
and "Karnataka Legislative Council Secretariat" w.e.f. 15th
August, 1997 subject to the following conditions:

- The KLA Secretariat and the KLC Secretariat shall function under the administrative control of the Hon'ble Speaker and the Hon'ble Chairman respectively.
- 2. The existing staff of the combined Secretariat shall be allocated to KLA Secretariat and KLC Secretariat by the Secretary, Karnataka Legislature after obtaining an option from the employees. If more than the required

number of persons opt for one Secretariat or the other, then allocation shall be made having regard to the seniority and the required number of employees required for Assembly Secretariat shall be allocated and the remaining employees shall be allocated to Council Secretariat.

- 3. The administrative control and maintenance of L.H. shall vest with the LA Secretariat for common use of Members of both the Houses of Legislature.
- 4. The Library, Reference and Research and Translation Wings shall be under the control of LA Secretariat for common use of Members of both the Houses of Legislature.
- 5. Separate C & R Rules for KLA and KLC Secretariat shall be issued based on the existing C & R Rules with necessary modifications.
- 6. All financial matters connected with LA and LC and its Secretariat shall independently west with the Speaker and the Chairman respectively.
- 7. The Budget Wing shall be under the control of LA Secretariat. The Budget allocation for the remaining period of the current financial year is to be inter-allocated suitably by I.F.A. for KLA and KLC Secretariats for the next financial year i.e. 1998-99 shall be prepared separately and sent to Finance Department with the approval of Speaker/Chairman, as the case may be.
- 8. The work to be dealt with and the number of posts in each cadre and sections for KLC Secretariat depending upon the workload shall be ad indicated vide Annexure.
- 9. All posts other than those specifically allocated to KLC Secretariat vide Annexure shall remain allocated to with KLE Secretariat.
- 10. All items of work other than the work specifically allocated to KLC Secretariat, shall continue to be dealt with by the KLA Secretariat.

- 1. All matters connected with the work of the **Legislative** Council and its Committees including 5 subject committees coming under the purview of L.C.
- 2. All matters connected with the functioning of the adhoc committees and select committees, if any, of the council constituted, from time to time.
- 3. All work connected with the administration of KLC Secretariat.
- 4. All work connected with watch and ward and security, arrangements in the precincts of LC chamber and its Secretariat.
- 5. All work connected with the payment of salary, pension, TA,DA and other allowances to the Members of Legislative Council, Chairman, Deputy Chairman, LO & GCW of LC.
- 6. All work connected with the payment of salary, TA, DA and other allowances to the staff of KLC Secretariat including the staff borne on the establishment of Chairman, Deputy Chairman, LO & G.C.W. of LC.
- 7. All work connected with the service regulations and administration of the staff of LC Secretariat including the staff borne on the establishment of Chairman, Deputy Chairman, L.O. & G.C.W. of L.C.
- 8. All work connected with providing office furniture, equipments, stationery and maintenance of the offices of the LC Secretariat including the offices of the Chairman, Deputy Chairman, L.O. and G.C.W. of LC.
- 9. All matters connected with the special Board of LC Secretariat.
- 10. All matters connected with providing and maintenance of office chambers to the Chairman of 5 subject committees coming under the purview of LC Secretariat.

- 11. All matters connected with protocal arrangements for receiving/see off of the visiting Committees (other than the sister Committees) from other States coming under the purview of LC Secretariat and to arrange for functions organised by LC and its Secretariat, from time to time.
- 12. Any other matter connected with the LC Members and LC Secretariat.
- II. WORK OF THE LC SECRETARIAT shall be dealt with by the following sections:

1. LEGISLATION SECTION:

All work connected with the LC and its Committees like previleges Committee, Adhoc Committees if any, select Committees of LC if any and other Adhoc Committees constituted by LC from time to time.

2. QUESTIONS SECTION:

- 1. All work connected with the notices of questions, Call Attention Notice, Notices under Section 330, Notices of Half an Hour Discussion, Notices for Discussion for Short Duration, and other notices connected with the LC.
- ii. Work connected with the Committee on Private Members Bills.
- iii. Work connected with the petition Committee of L.C.
 - iv. Work connected with the Committee on Government Assusrance.
 - v. Any other work connected with LC.

3. ACCOUNTS SECTION:

i. All work connected with the payment of salary, pension, TA, DA and other allowances of the Members of L.C.

- ii. All work connected with the payment of TA, DA to the Members of LC appointed as Members of various Committees.
- iii. All work connected with the payment of salary, TA, DA, and other allowances of the staff of LC Secretariat including the staff borne on the personal establishment of Chairman, Deputy Chairman, Parliamentary Functionaries and Secretary.
 - iv. All work connected with the sanction of all other advances and pensionary benefits etc., to the staff of LC Secretariat including the staff borne on the personal establishment of Chairman, Deputy Chairman, LO. & G.C.W., and Secretary of L.C.

4. ADMINISTRATION SECTION:

- 1. All work connected with the appointment/promotion/ deputation etc, of staff of LC Secretariat.
- ii. All work connected with the service rules, security and other matters pertaining to the staff of LC Secretariat including the staff borne on the personal establishment of Chairman, Deputy Chairman, L.O., G.C.W. of L.C.
- iii. All matters connected with the special Board of LC Secretariat.

5. EXECUTIVE &R&I SECTION:

- 1. All work connected with the purchase, providing and maintaining for office equipment and furniture, Stationery etc. for the use of the office of the personal establishment of Chairman, Deputy Chairman, L.O. and G.C.W. of LC and LC Secretariat.
- ii. All work connected with Receipts and issue of tappals pertaining to LC and its Secretariat.
- iii. All work connected with the furnishing of offices of residences of the Chairman, Deputy Chairman, L.O. and G.C.W. of L.C.

6. SUBJECT COMMITTEE SECTION:

There shall be two subject committee sections to look after the work of 5 subject committees that come under the purview of the LC Secretariat.

7. REPORTING & EDITING SECTIONS:

All work connected with the reporting and editing of the proceedings of LC and all committees allocated to LC Secretariat.

8. PROTOCOL & WATCH & WARD SECTION:

- 1. All work connected with the security, maintenance and watch and ward of LC Chambers, Chambers of 5 subject committees Chairman, and the offices of the LC Secretariat.
- ii. All work connected with receiving and security of the committees (other than sister committees) and visiting committees of other States coming under the purview of LC Secretariat.
- iii. Any other work of protocal or arrangement of functions organised by LC and its Secretariat.
