the date by which trees are imperative to be removed not be less than 45 days per 50 trees in the enumeration list, from the date on which the enumeration list is being submitted. The user department and the concerned Deputy Conservator of Forests should meet as frequently as possible, but certainly at 16:00 hours on the last working day of each calendar month to discuss the enumeration list, action taken on previous enumeration lists and other related matters.

B. ACTION TO BE TAKEN ON ENUMERATION LIST (BY FOREST DEPARTMENT);

- 1. After the enumeration list has been received, the jurisdictional Deputy Conservator of Forests should, and in no case later than the 15th day of the month subsequent to the month in which the enumeration list is received
 - (a) Get the contents of the enumeration list submitted by the user department verified, and corrected where and if necessary, the species, measurements recorded, estimates of volumes and monetary value of each tree, depending upon the likely cost of extraction and quality of timber/firewood etc.,
 - (b) Where felling permission for trees is not required by virtue of the non-applicability of section 8(3) of the Karnataka Preservation of Trees Act, 1976, to the place where the tree exists or because of the exemption of the species from felling permission, or both, intimate to the user department and collect the cost of planting 10 seedlings (at the rate of Rs. 300 for every seedling to be planted) for every tree to be felled is received (This rate shall be valid up to the year 2019-20),
 - (c) Where felling permission for trees is required, but trees are not that of Rosewood or Sandalwood, and he/she is the Tree Officer, give, and when he/she is not the Tree Officer take all action required of him/her to get the felling permission for trees enumerated, the felling permission being valid from the date on which the cost of planting 10 seedlings (at the rate of Rs. 300 for every seedling to be planted) for every tree to be felled is received (This rate shall be valid up to the year 2019-20), and,
 - (d) Where the tree/trees are of the species Rosewood or Sandalwood, get the tree/trees departmentally extracted within the end of 30 days from the day on which the cost of planting 10 seedlings (at the rate of Rs. 300 for every seedling to be planted) for every tree to be felled is received (This rate shall be valid up to 2019-20).
- 2. After the felling permissions (where needed) have been given, and the cost of planting 10 seedlings for every tree intended to be felled has been collected, the cost of raising roadside plantation for the length of the road laid/widened should be collected by the jurisdictional Deputy Conservator of Forests from the user agency at the rate of Rs. 3.00 Lakhs per Kilometre (This rate shall be valid up to the year 2019-20) of the length of road being laid/widened. This payment will be applicable irrespective of whether the user department takes up planting roadside trees in lieu of the road length laid/widened or not.
- 3. After all the above has been done and the charges as detailed above collected, the competent authority of forest department should sanction the upset price of the trees enumerated. These trees then should be offered (by intimation in writing) to the user department for being purchased by it, or a representative of theirs, at the upset price plus all statutory taxes and charges. If the user department is agreeable to it, the trees should be given to them after collection of the price and taxes/fees etc.

For considering the offer, the user department should be allowed a time of not less than 21, but no more than 30 calendar days, from the date of the offer to communicate to the forest department their acceptance or denial. Failure to communicate within 30 calendar days from the date of the offer would imply that the offer has been declined.

In the event of the user department declining this offer or not communicating anything within 30 calendar days from the date of the offer made in writing, the trees should be disposed of by sale by e-tender-cum-auction by competent authority of the Forest Department as provided in **Appendix XVIII B** of Rule 64 Karnataka Forest Code, 1976, if the upset price is more than Rs. 3 lakhs, and by manual tender-cum-auction when the upset price is less than Rs. 3 Lakhs

Method of disposal of Roadside trees in non-forest lands during the road laying / widening process.

Read:

- File No. APCCF(FRM)B3.Sales.CR-84/2017-18 submitted by the Principal Chief Conservator of Forests (Head of Forest Force), Karnataka.
- Principal Chief Conservator of Forest (Head of Forest Force) Letter No: APCCF(FRM)B3. Sales. CR-74/2017-18, dated: 06.10.2018.

PREAMBLE:

In the single file read at (1) above, Principal Chief Conservator of Forest (Head of Forest Force) has stated that in the Video Conference meeting held under the Chairmanship of Chief Secretary, Government of Karnataka with all the Deputy Commissioners of the Karnataka State on 08.08.2018 to discuss the progress in road widening and road laying projects. It was found that there was a need to streamline and improvise the method of disposal of trees that are required to be removed in the process. It was opined that a new Government Order / Circular may be issued for laying down a method of disposal of trees that is consistent with the existing laws and procedure and acceptable to the departments who are involved in the road laying/widening project as well as the Forest Department.

As per the directions given in the meeting held on 08.08.2018, a meeting was held under the Chairmanship of Additional Chief Secretary, Forest, Ecology and Environment Department along with the officers of the Forest department and the National Highways Authority of India (NHAI) on 15.09.2018. Yet another meeting in the matter was held on 01.10.2018 chaired by the Hon'ble Chief Minister, Government of Karnataka, along with the Hon'ble Minister, Public Works Department, Government of Karnataka, the Chief Secretary, Government of Karnataka, the Additional Chief Secretary, Public Works Department, National Highways Authority of India (NHAI) and other Senior Officers of the Forest Department. The National Highways Authority of India (NHAI) had requested that the roadside trees needing to be removed for road laying/widening be offered to them at seigniorage rates of the forest department so that they can dispose them off at the earliest.

Further, based upon the deliberations and decisions held on the above said meetings, a revised proposal was submitted by the Principal Chief Conservator of Forests (Head of Forest Force) vide letter dated: 06.10.2018. The said proposal contained the provision of offering roadside trees needing to be removed for road laying/widening at seigniorage rates of the Forest Department to the user Department.

As per the Rule 85 of the Karnataka Forest Rules, 1969, forest produce can be sold by a method other than sale (a) by auction or tender or tender-cum-auction, (b) at sanctioned schedule of rates in depots and (c) issue of licenses at the seigniorage rates, "with the previous sanction of the Government whenever the Chief Conservator of Forests considers it desirable to do so in the interest of the Department".

Hence, the following order.

GOVERNMENT ORDER NO. FEE 168 FDP 2017, BENGALURU, DATED:06.12.2018

As explained in the preamble, the procedure and methodology that should be followed for disposal of roadside trees required for road laying/widening in forest lands are explained in the annexure enclosed to this order.

This order will come in to force with immediate effect and until further orders, superseding all previous circulars/directions issued in this matter.

Annexure for the Government Order No: FEE 168 FDP 2017, dated:06.12.2018

A. PREPARING ENUMERATION LIST OF TREES TO BE FELLED AND ITS VALUATION (TO BE DONE BY USER DEPARTMENT):

- 1. The user department (NHAI/PWD etc.) should prepare the enumeration list in **Proforma-A** enclosed. In it, the user department should record as accurate a location of the trees to be felled, as possible. Different enumeration lists should be prepared for each kilometre of the road where felling is to take place. Trees along the left of the proposed road/widening of road will, after the tree number as well as the species of the tree noted in the enumeration list, carry the suffix (L). Trees on the right of the proposed/widening will, after the tree number as well as the species of the tree noted in the enumeration list, should carry the suffix (R).
- 2. Each tree intended to be felled should be recorded in the enumeration list after, (a) identifying the species of the tree, (b) assigning to each tree an unique but continuous number for the project as a whole [A road going from X to Y having N trees will have the numbers 1 to N], (c) marking the tree in white / yellow paint all along the perimeter of the tree at a height of 137 cms (called breast height of tree in forest mensuration), (d) painting the unique number of the tree in red paint at the breast height white / yellow band on the face nearest to the road, such that each digit of the number is not less than 1 cm in thickness and is contained in a square of size of no less than 20 cms x 20 cms, (e)measuring by a flexible inelastic tape the girth of the tree in centimetres at breast height (length of white/yellow ring detailed before), and, (f) estimating the height (in meters) of the tree up to the leading tip i.e. the part of tree that is seen at maximum height above ground.
- The enumeration list should have estimates of volumes of healthy, undamaged and sound trees as follows, namely-
 - (a) Timber volume in cubic mts = $g^2h/800000$, when g>80 cms and 0 otherwise,
 - (b) Firewood volume in cubic mts. = g²h/200000, when g> 80 cms and g²h/160000 otherwise,

When g = girth at breast height of tree in cms.

h = height of tree (up to leading tip) in meters.

- 4. The value of the tree too should be estimated in the enumeration list using the seigniorage rates for timber (species wise) and firewood that are notified by the Principal Chief Conservator of Forests (Head of Forest Force) from time to time.
- 5. The user department should send hard and soft copies of the enumeration list of each month, on or before the last working day of the month, to the jurisdictional Deputy Conservator of Forests along with the date by which it will be imperative to have the trees removed. However,

In the event of the auction being unproductive, or when the Minimum Reserve Price is not received, the forest department should extract the trees departmentally and transport to the nearest depot and sell it in the same manner as timber and other forest produce is usually sold by the., The cost of extraction of trees in this case shall be payable by the user department.

C. REVENUE SHARING IN PROCEEDS OF SALE:

1. In the event of disposal of trees been done by auction method, or where the trees have been extracted by the forest department and sold by way of auction, all revenue shall go to the Government of Karnataka through the Forest Department.

Note: For the purpose of understanding the meaning of all the above provisions, "Tree" means the same as defined in Section 2(g) of the Karnataka Preservation of Trees Act., 1976, i.e. any woody plant whose branches spring from and are supported upon a trunk or body and which trunk or body is not less than five and a half centimetres in diameter and not less than one meter in height from the groundlevel and includes palms, bamboos, stumps, brushwood, canes and seedlings of such tree but does not include sandal and rosewood trees.

D. USAGE OF THE CHARGES COLLECTED:

- 1. The cost of planting 10 seedlings for every tree felled/purported to be felled should be endeavoured to be utilized for raising and planting at least 10 seedlings raised in bags of size 8" x 12" or bigger in a block plantation preferably in the same taluk from which the trees have been/are being removed. In case there is no area available in which such block plantation is capable of being raised, the plantation may be raised in any other taluk of the same district, but not outside the district.
- 2. The amount of Rs. 3.00 Lakhs per kilometre of the length of road being laid/widened should be endeavoured to be utilized to raise roadside plantation along the road laid/widened for which the felling of trees has taken/will take place. In case it is not possible to raise roadside plantation along the road laid/widened, the roadside plantation will be raised along any similar road (National Highway for National Highway, State Highway for State Highway etc.) or any other road in the same taluk. In case there is no road available in which such roadside plantation is capable of being raised in the taluk, the plantation may be raised along any similar road (National Highway for National Highway, State Highway for State Highway etc.) in some other taluk of the same district, but not outside the district.

E. REVISION OF CHARGES:

The cost of planting seedlings for every tree purported to be felled, and the cost of raising roadside plantation for the length of the road laid/widened may be revised and notified by the Principal Chief Conservator of Forests (Head of Forest Force), Karnataka, with prior approval of the State Government.
