

SECTION 3

TERMS AND CONDITION

1. The Agency/Service Provider should be an Indian National
2. The Agency/Service provider should be compliant with the adventure guidelines issued by Govt. from time to time.
3. The agency/service provider should have a minimum of 2 years of experience in conducting White Water Rafting activity of similar nature and who have experience and qualified manpower in disciplines of conducting Water sports activities certificate issued by recognized institute to run such facilities.
4. Joint proposals will not be accepted.
5. The Agency/Service Provider should have GST Registration Certificates.
6. The Agency/Service Provider should have a certificate of Registration with Department of Labour, Government of Karnataka.
7. The Agency/Service Provider should be compliant with the adventure guidelines issued by Government from time to time.
8. The Agency/Service Provider should have qualified manpower to conduct all disciplines of Conducting White Water Rafting activity.
9. The resource persons/guides should have extensive experience and deep knowledge and appreciation of the wilderness environment. They should also possess where it is insisted by any law.
10. All the activities should be carried out under stringent safety conditions by qualified and experienced instructors and resource persons who should be fully aware of all the safety standards of the equipments used and activities involved. In case of any accident, the Agency/Service Provider will be solely responsible for any consequences/liability thereof.
11. Sufficient medical aid including medicines for emergency should be made available at the site. The Agency/Service Provider should engage medical attendants for immediate necessity and provide first aid.
12. The Agency/Service Provider should have accreditation with bodies like National Adventure foundation, Indian Mountaineering Foundation or any similar statutory bodies of one the set patterns for imparting training in adventure sports.
13. The rates quoted by the Agency/Service Provider should be in Indian Rupees for a period of 3 years only. The Agency/Service Provider is not permitted to sublet/transfer the conduct of business.
14. All the equipment and accessories required for carrying out the White Water Rafting activity will be provided by the Agency/Service Provider and these will be maintained in high standard.
15. The Agency/Service Provider shall ensure that its Officials/Guides/Experts/Operators and Guests/customer do not violate any of the conditions of the Karnataka Forest Act, 1968, Karnataka Forest rules 1969, the Forest (conservation) Act, 1980 and the Wildlife (Protection) Act, 1972, or any other law (including the orders/guidelines) in force. In case of any violation, apart from the customer concerned, the Agency/Service Provider shall be held responsible.
16. In the case of any dispute arising between the Agency/Service Provider and the Employer such matter shall be referred to the notice of the Deputy Commissioner, Chikmagalur for arbitration and his award will be final and binding on the Agency/Service Provider. The

Deputy Commissioner at his discretion delegate in writing to any other subordinate any his power regarding the agreement.

17. In addition to above the Agency/Service Provider shall abide by the following Act and Rules:
 - i. The Payment of Wages Act, 1936
 - ii. The Workers compensation Act, 1923
 - iii. The Contract Labor (Regulation and Abolition) Act, 1970
 - iv. The Employees Provident Fund and Miscellaneous Provisions Act, 1952
 - v. The Child Labour (Prohibition and Regulation) Act, 1936
 - vi. The Minimum Wages Act, 1948
 - vii. Other relevant Acts and Rules
18. Flow of water in the river course/quantum of the water in the river course is not assured in any manner. It is purely a situation which is beyond the control of the Deputy Commissioner and no claims/liabilities in this regard will be entertained.
19. The Agency/Service Provider must take all precautions to avoid any accidents during rafting in case of any claims from the clients due to any accidents, sickness, death, injury, disability, etc., arising at any point of the rafting activity in the river proper or during the conveyance of the rafting guests, such claims shall be met by the Agency/Service Provider. The Deputy Commissioner will not be party to any of such claims.
20. All employees of the Agency/Service Provider working shall have identity cards with photographs.
21. The Guides should be trained and proficient in dealing with a surfing raft.
22. The Guides should be familiar with international river signals.
23. No guides shall be put on the raft without their credentials being verified by the authorized officers.
24. The decision of the Technical Committee scrutinizing the technical proposals is final and binding.
25. The Agency/Service Provider/Service Provider should have minimum financial turnover of Rs. 10,00,000/- of each for last 3 financial years. Copy of Audited balance sheets of last 3 FY shall be submitted as evidence of Annual Turnover to be enclosed.
26. Area of Operation: the Agency/Service Provider should conduct the White River Rafting in the designated stretch, i.e. Rafting -06km down the stream from Balchele to the end of Kalasa police station jurisdiction (total stretch of 6KMs) only. The Agency/Service Provider should not operate the rafts beyond the designated area.
27. A rescue boat/Kayak must be available in full readiness during the entire period of water sport operation. This boat is powered by OBM of minimum 10HP. A lookout-cum-boat driver must be standby near the boat. The boat as well as the lookout should not be involved with any other activity while on rescue duty.
28. Period of Operation: the rafting should be carried out between 9.00 am to 5.00pm, and the rafting should be restricted to day light hours only.
29. Raft Operators Qualifications
 - a) The River Guide must hold valid certification of competency from NIWS or a national governing body recognized by the MCT.
 - b) He must also hold a Life Saving Technique (LST) certification from NIWS or an equivalent certification from reputed national governing Body.
 - c) they must complete two familiarization runs under supervision before the commencement of each season and before undertaking commercial runs.
 - d) Minimum age for guides is 18 years

22. Equipment and Accessories:

- a) The Agency/Service Provider should have Rafts with NIWS standards
- b) The Agency/Service Provider should keep at least Boats/Kayaks as spare on the water during operation.
- c) All trips must carry a well-equipped First Aid Kit (containing triangular bandages, sterile pads, gauze roller bandages, pressure bandages, First Aid adhesive tape, splints, scissors, and repair kit (containing half meter of repair material, glue and accelerator, sand paper and waterproof repair tape).
- d) All rafts must have a safety line going all around the raft. Besides, a bow-line and a stern line are also preferred.
- e) A raft must have a throw bag and a bailing bucket
- f) A dip line is recommended for all big drops
- g) Appropriate shoes/sandals/boots are a must for rafting.
- h) Suitable Clothing are recommended for River Rafting. In their absence, light weight synthetic cloths are suggested but cotton is to be strictly avoided.

23. Operating Instructions:

- 1) All rafters/kayakers including guides must strictly wear a life jacket at all times when in the water. The life jackets must have adequate buoyancy (minimum of 6.14 kg, it preferably 9 to 10kg), must meet the specification of US coast guard type III or V. Inflatable and the "keyhole" type jackets are not recommended.
- 2) Guides must ensure that the life jackets are worn "snugly" before the trip starts.
- 3) Helms are mandatory for rafters irrespective of whether the rafting takes place through rapids or under normal flow. It should also be properly strapped.
- 4) Non-swimmers should not be allowed on rapids above Grade III
- 5) Guides/Expedition leader must ensure that a thorough safety briefing, covering all pertinent details for a particular trip, is given before each trip. The trip leader must ensure that guests are in suitable attire (bulky cloths, sarees, turbans, neck ties, long shirts and three piece suits are to be totally avoided)
- 6) People suffering from any serious ailments, weak heart conditions, and epilepsy and expectant mothers should not be allowed on raft.
- 7) Non-swimmers should not be allowed to body-surf.
- 8) The trip must be timed in such a manner to finish it at least an hour before sunset.
- 9) Any body consumed alcohol (in any form or quantity) or illicit drugs at least six hours prior to the expedition must not be allowed to get on the raft.
- 10) The river and its premises must be kept clean.
- 11) Nothing should be done to offend the local people or to harm the flora and fauna of the area.
- 12) It is mandatory for all outfitters and guides to maintain a log book. It should contain the details of the trip viz. number of boats/passengers, river map, river geography including gradient, rapids and its height/elevation, water level, velocity, gadgets on board, accident or untoward incidents or injuries etc. the outfitter and guide log books must be signed by the senior guide/Expedition leader after every expedition
- 13) The Agency/Service Provider should install the Electronic Ticketing System at the Ticket Counter
- 14) The operator shall insure the passengers as per maximum carrying capacity of 08 persons/Raft
- 15) The operator shall display the carrying capacity of the boat as in the registration certificate, emergency contact details, validity of Registration and the display will be of appropriate size at a Prominent Place
- 16) The Operator should provide tourist Customer Amenities such as Dress changing room, Wash Room and Clock room and facilities at the Venue.

- q) The Agency/Service Provider/Service Provider should not stop work the rafting when the water flow in the river reached danger mark

32. Penalty

- a) Any operator who causes harm/injury/death to a tourists/general public/third party on account of their nations/irresponsible behavior negligence or the raft being operated in unfit condition etc shall be punished as per the relevant Penal Law for time being in force shall be liable for any claim/Compensation claimed.
- b) During the pendency of trial, the of the operator shall be suspended barring from operating any water sport activities
33. The Agency/Service Provider should quote the bid amount at their own risk. The bid amount quoted in the RFT proposal will not be considered for the award of contract under any circumstances.
34. The Agency/Service Provider should comply with the statutory norms of the Government
35. Agency/Service Provider shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued by any State Government/Government of India/Union Territory.
36. Agency/Service Provider are advised to visit the rafting site sufficiently in advance before the last date fixed for submission of the RFT. The Agency/Service Provider shall be deemed to have full knowledge of all the relevant documents area etc. whether he inspects them or not.
37. Agency/Service Provider or their authorized agents alone are allowed to participate in the opening of the Technical Proposals of the RFT
38. The RFT will undergo evaluation at every stage of processing and any Agency/Service Provider found at any stage, not in conformity with the stipulated conditions including specifications found to be having defective and incomplete, the documents will be rejected.
39. Proposal preparation Cost: the Firm/ Agency/Service Provider shall be responsible for all costs associated with the preparation of its proposal and participation in the process. The DTDC will not be responsible nor in any way liable for such costs, regardless of the conduct and outcome of the process.
40. In the event of dispute the dispute would be subjected to the jurisdiction of the court in Chikkamagaluru only.
41. The proposals not in accordance with the Terms and Conditions of this RFT Notice will be rejected outright.
42. The earnest money deposit of Agency/Service Provider will be returned within 30 days of the end of the RFT validity period
43. The earnest money deposit may be forfeited:
- a) If the Agency/Service Provider withdraws the quotations after RFT opening during the period of RFT validity.
- b) If the Agency/Service Provider does not accept the correction of the Quoted Price or Security Deposit.
44. The RFT are invited from the Eligible Agency/Service Provider to quote the BID AMOUNT only and under any Circumstances, the proposals (RFT) submitted by the Agency/Service Provider will not be considered for the award of contract to Carry Out White water rafting activities in Bhadra River, from Kerekalgadde to Balehole, Mudigere Taluk of Chikkamagaluru District.
45. The Deputy Commissioner, Chikkamagaluru district shall have the right to accept or reject the Proposals/Quotations without assigning any reasons.
46. Others:
- i) The Agency/Service Provider has to display a signboard showing the time schedule tariff, routes earmarked time stipulated etc for information of the tourists, and adhere to the same, the raft should be taken on the stipulated routes, to the convenience of the tourists, within the specified time, without any complaints or whatsoever. The display contents shall be approved by the Deputy Commissioner and Chairman, DTDC Chikkamagaluru District.

- ii. The Agency/Service Provider is responsible for accident/injury caused to tourist during rafting due to negligence of Agency/Service Provider
- iii. The Agency/Service Provider or his authorized agent should take all precautions and care not to disturb the flora and fauna in and around the Cauvery River while taking tourists in the raft.
- iv. The Agency/Service Provider shall take all precautions to keep the river and the adjoining forest free from any litter and also ensure that there is no fire damage to the surrounding forests. Failure to comply will attract penalty and legal action from the District Administration.
- v. The Agency/Service Provider is not entitled to entertain film shooting and extending such facilities without the permission of Deputy Commissioner
- vii. No claim of the Agency/Service Provider is not entitled to entertain film shooting and extending such facilities without the permission of Deputy Commissioner.
- viii. The Agency/Service Provider shall always be bound by the directions and instructions that might be issued by the District Administration from time to time and these shall be binding on him.
- ix. On violation of any of the above mentioned conditions by the Agency/Service Provider the Deputy Commissioner, shall have all powers to take needful action such as imposing fine, ordering temporary closure of operation suspending right on running the rafts, terminating contract, and or confiscating part/complete depending upon the nature of the violation
- x. The District Administration or their authorized representatives will have the right to inspect and review the rafting activity from time to time and impose fines and take action as per the agreement.
- xi. The Agency/Service Provider shall ensure proper documentation regarding the number of tourist, number and type of vehicles, number of trips, names of guides, etc. in a prescribed proforma, and submit the same to the Deputy Commissioner or to his subordinates at an every interval of 30 days.
- xii. The Agency/Service Provider shall pay all statutory taxes like the Income Tax Service Tax etc. as applicable regularly for non-payment of the taxes, the Deputy Commissioner will not be responsible.
- xiii. The Agency/Service Provider bringing authorized tourists for rafting should enter only at recognized entry jetty point and go back through authorized exit jetty point with due supervision of the staff of the Agency/Service Provider
- xv. The Deputy Commissioner shall reserve the right of addition or deletion or modification of any of the conditions stipulated in this agreement from time to time depending upon the requirements and emerging situation and that shall be binding on the Agency/Service Provider
- xvi. Computerized billing should be done by the Agency/Service Provider. The agency/service provider should furnish the billing details once in a month.
