

Applications are invited from eligible Indian Nationals for the following posts (Total 174 Posts) in the Operation & Maintenance Wing of BMRCL. While the details are available on the BMRCL website, following may be noted:

- Please see detailed instructions for applying on-line as given at 'B' - "Instructions for filling up the Application form" at Annexure -1 to this Notification
- Applications will be received on-line only. No paper applications or applications through post / email etc. will be accepted.
- Knowledge of Kannada is a must. (The candidate should be able to Read, Speak, Understand and Write in Kannada).
- Possession of Essential Educational Qualification prescribed in Col. No. 3 is a must. The candidate should have scored minimum 50% marks. In the essential educational qualification prescribed. The said 50% should be computed by averaging marks of all the years in the entire course like ITI/ Diploma / BE as the case may be. i.e. total marks obtained in all years divided by maximum marks of all examinations. In case, instead of marks, Grades have been given, the middle figure of the range that the Grade covers should be taken as marks obtained for each subject and total percentage computed as per above prescribed procedure. Eg: If Grade 'A' range is 80 - 100, middle figure : 90 should be taken as marks obtained. The ITI Certificate should be recognised by NCVT / SCVT, Diploma / Degree should be from an Institute/Organisation recognised by AICTE. Candidates possessing qualification equivalent to the relevant stream of ITI / Engineering Degree / Diploma may apply subject to the condition that they should produce satisfactory documentary proof from NCVT/ SCVT / AICTE / Directorate of Technical Education, Govt. of Karnataka certifying the said equivalence. Such document needs to be produced for verification when called for. If such document is not produced, the candidate shall be disqualified irrespective of his/her position in the merit list prepared on the basis of the written test.

As on 02.02.2019 age of the Candidate should not exceed the maximum age prescribed for the post. For Ex-Servicemen, the relaxation in age shall be equivalent to the number of years of service in armed forces plus 3 years, but in any case the maximum age not to exceed 50 years as on 02.02.2019. (Please see Serial No. 2 of General Instructions).

1. GENERAL INSTRUCTIONS:

1.01 On-line applications forms are available on BMRCL website : www.bmrc.co.in. Candidates are required to go to BMRCL website and fill up the application online. Detailed instructions regarding filling up of application is given under the heading "How to Apply" at Annexure 1. Please note that no application on paper including hand written or typed will be entertained. For any doubts or difficulty in filling up the application online, candidates may contact BMRCL Help Desk at helpdesk@bmrc.co.in or 080 22969200 during office hours on all the working days.

1.02 Before applying for any post, the candidate should ensure that he/she fulfills all the eligibility norms. The candidate should have the requisite Educational /Technical qualifications as on the closing date of submission of the application. Those awaiting results of the final examination need not apply. The ITI Certificate should be recognized by NCVT/SCVT. The Degree /Diploma should be from an Institute / Organization recognized by AICTE.

Candidates possessing qualification in the equivalent stream to the relevant Engineering Degree /Diploma / ITI may apply subject to the condition that they should produce satisfactory documentary proof in support of the equivalence. If such a document is not produced the candidate shall be disqualified irrespective of his /her position in the merit list prepared on the basis of the written test.

Knowledge of Kannada in all the four attributes viz., reading, speaking, writing & understanding, is compulsory for all the posts. Knowledge of Kannada will be tested at the time of document verification. **Those who do not have knowledge of Kannada will be disqualified irrespective of the marks scored in the written test.**

1.03 The number of vacancies indicated in this Employment Notification is provisional and may increase or decrease depending upon the actual need. BMRCL also reserves the right to cancel the notified vacancies at its discretion and such decision will be final and binding on all. In the event of cancellation of notified vacancies, the examination fees paid by the candidates will not be refunded.

1.04 Examinations will be held in Bangaluru, Mysuru, Belagavi and Kalaburagi. In the morning session exam will be conducted for Maintainers & Section Engineer and in the afternoon session exam will be conducted for Junior Engineer. If you applied for two posts i.e both Junior Engineer and Section Engineer or Junior Engineer and Maintainers, and wish to get one centre for both the exams then you must map your application numbers of both the posts in the option given at our website.

1.05 Seniority of the Systems & Civil candidates in both the Section Engineer / Junior Engineer cadres shall be determined by combining, based on the marks obtained in the examination conducted by the KEA.

1.06 Shortlisting of candidates by BMRCL does not confer upon candidates any right of appointment in BMRCL.

1.07 Selected candidates will have to undergo training wherever required.

1.08 Emoluments on initial appointment will be minimum pay of the pay scale of the post plus other allowances admissible at that time. Candidates may have to give security deposit and execute indemnity bond wherever necessary.

1.09 Reservation for SC / ST / Cat I, Cat IIa, Cat II b, Cat IIIa and Cat III b

All candidates irrespective of community may be considered against GM vacancies. Against the vacancies earmarked for specific community (SC/ST/Cat I, Cat IIa, Cat IIb, Cat IIIa and Cat IIIb), only candidates belonging to that community /group will be considered. For this purpose, (SC/ST/Cat I, Cat IIa, Cat IIb, Cat IIIa and Cat IIIb) candidates should furnish Caste Certificate issued by competent authorities of the Government of Karnataka. Certificates are to be submitted in the formats prescribed by Government of Karnataka as indicated below:

- SC / ST candidates should furnish certificate in Form 'D'
- Category I candidates should furnish certificate in Form 'E'
- Category IIa, IIb, IIIa, IIIb candidates should furnish certificate in Form 'F'
- Certificates obtained from the concerned Tahsildars in the relevant Format will only be accepted.
- Candidates claiming reservation under rural quota should produce relevant certificate in Form 2.
- General Merit candidates claiming reservation under rural quota should also produce certificate in Form 1 certifying that they do not fall under the creamy layer prescribed by Government of Karnataka.
- Candidates claiming reservation under Kannada Medium quota should produce certificate in the format prescribed by the Government of Karnataka, certifying that he / she has studied in Kannada medium from Standard I to X.
- Candidates claiming reservation under Project displaced persons should produce "Project Displaced person certificate" as prescribed in the G.O. No. DPAR 23 SRR 99 dated 23.11.2000 issued by the Tahsildar.

Ex-Servicemen:

For Ex-servicemen, Certificate of discharge issued by the competent authority in Army / Navy/ Air force indicating date of birth, date of joining, date of discharge and post held to be produced.

1.10 Candidates claiming reservation under Hyderabad – Karnataka Region (Under Article 371 (J)) should produce relevant eligibility certificate as prescribed under Karnataka Public Employment (Reservation in appointment for Hyderabad-Karnataka region) (Issue of eligibility certificates) Rules, 2013 issued by the competent authority as in Government Notification I and II No. DPAR 43 HKC 2013

Bangalore dated 29.1.2014. (Eligibility certificate in the format as in Annexure A attached to the above Notification of GoK).

1.11 Women candidates may note that duties in the Company may be arduous in nature and require working in shifts.

1.12 Any subsequent changes in the terms and conditions of this Employment Notification as per extant rules will stand good. BMRCL reserves the right to consider/incorporate any subsequent changes/modifications/additions in the terms & conditions of recruitment under this Employment Notification as necessitated and applicable.

2. AGE LIMIT

As on 02.02.2019, the upper age limit is as under:

2.01 For General Merit candidates – 35 years

2.02 For SC/ST/ Cat I candidates - 40 years (35 yrs plus 5 yrs)

2.03 For candidates under Cat IIa, IIb, IIIa, III b – 38 years. (35 yrs plus 3 yrs)

2.04 For Ex-servicemen, the relaxation in age shall be equivalent to the number of years of service in armed forces plus 3 years, but in any case the maximum age not to exceed 50 years as on 02.02.2019.

2.05 Candidates should note that the Date of Birth as recorded in the Matriculation/High School Examination Certificate or equivalent Certificates as on the date of submission of applications will only be accepted.

3.01 SC/ST candidates – Examination fees – Rs. 354 (including 18%GST)

3.02 GM, Cat I, Cat IIa, Cat IIb, Cat IIIa, Cat IIIb candidates – Examination fee is Rs. 826/- (including 18% GST)

4. RECRUITMENT PROCESS:

4.01 The selection will be made strictly as per merit, on the basis of written examination. Short listed candidates will be called for verification of the original documents and Kannada test followed by Medical Fitness Test, if cleared in the verification and Kannada test.

4.02 There shall be no negative marking in the written examination.

The question paper will be of objective type with multiple answers. The question paper will be bilingual i.e. in English and Kannada and the duration of the examination will be for 2 hours with 100 questions. The question paper will also contain writing one paragraph / sentence in Kannada which is compulsory and this
