- a) Funds that are contributed by the Founder members of the Society.

- d) The funds and profits, if any, or other income of the Society shall be utilized solely towards promoting the aforesaid Aims and Objectives and there shall be no payment of dividends or income or profits to members.

4. Aims and Objectives :

The aims and objectives of the Association shall be as set out in the Memorandum of Association.

5. DEFINITIONS

In these Rules and Regulations, unless the context requires otherwise.

- a) 'Act' means the Karnataka Societies Registration Act, 1960
- b) "Association' means Sir. M. Visvesvaraya Nagar BDA Layout (Further extension) 8th Block Residents' Welfare Association. __

9. GENERAL BODY MEETING

- a) The Committee shall call for a General body Meeting at least once a year, within two months of the close of the financial year, or as often as found necessary. 


AMENDMENT TO THE MEMORANDUM OF ASSOCIATION AND RULES AND REGULATIONS.



THIS WRIT PETITION IS FILED UNDER ARTICLES 226 AND 227 OF THE CONSTITUTION OF INDIA, PRAYING TO CALL FOR THE ENTIRE RECORDS FROM THE R-2, WHICH ULTIMATELY RESULTED IN PASSING THE RESOLUTION ANNEXURE-A DATED 15.12.2018 IN SUBJECT NO.32/2018 IN SO FAR AS IT RELATES TO ITEM NO.9, ALLOTTING THE CA SITE BEARING NO. 10A, PURSUANT TO THE ADVERTISEMENT ISSUED IN FAVOUR OF THE R-3 AND ETC.

THIS PETITION COMING ON FOR PRELIMINARY HEARING 'B' GROUP **THROUGH VIDEO CONFERENCE** THIS DAY, THE COURT MADE THE FOLLOWING:-

ORDER

The petitioner, a registered Association is before this Court under Article 226 of the Constitution of India questioning the correctness and legality of the resolution Annexure-A dated 15.12.2018 in Subject No.32/2018 insofar as it relates to Item No.9 allotting

- C.A. Site bearing No.10A in favour of respondent No.3 and for a writ of mandamus directing the respondent-BDA to follow Rule 7 of BDA (Allotment of Civil Amenity Site) Rules 1989 (for short 'the 1989 Rules').
- 2. Heard Sri M. Srinivasa, learned counsel for the petitioner, Smt.M.C. Nagashree, learned Additional Government Advocate for 1st respondent, Smt. Vanaja, learned counsel for the 2nd respondent, and Sri N. Jagadish Baliga, learned counsel for 3rd respondent. Perused the entire writ petition papers.
- 3. Learned counsel for the petitioner would submit that both the petitioner as well as 3rd respondent had made application to the 2nd respondent-BDA for allotment of sites in pursuance to notification dated 08.12.2017 (Annexure-E). The 2nd respondent-BDA by its resolution dated 25.09.2018 allotted Civic Amenity site in favour of the 3rd respondent herein. The said allotment of Civic Amenity site was the subject matter of

writ petition before this Court in W.P.No.48202/2018 disposed of 06.12.2018.

Sri M. Srinivasa, learned counsel for the petitioner contends that this Court while setting aside the allotment of Civic Amenity Site made in favour of the 3rd respondent had specifically directed the 2nd respondent-BDA to bunch all the applications on the basis of merit keeping in view the rule position. It is his contention. that the 2nd respondent-BDA failed to follow the direction issued by this Court as well as it had failed to follow Rule 7 of 1989 Rules. The learned counsel would contend that 2nd respondent-BDA without comparing the merit of the petitioner as well as the 3rd respondent in a mechanical manner passed the resolution to allot the civic amenity site in favour of the 3rd respondent. He submits that respondent-BDA ought to have examined the financial position, audit report and other relevant factors relating to the petitioner as well as 3rd respondent. Mere stating in the resolution that all the applications are considered would not be sufficient or it

would not be in compliance of Rule 7 of 1989 Rules. Learned counsel would invite attention of this Court to Rule 7 (1) (a) to (f) and submits that 2nd respondent-BDA is required to examine the criteria laid down therein. Failure to consider this criteria has resulted in miscarriage of justice. Thus he prays for quashing the resolution and to direct the respondent-BDA to consider afresh all the applications pending as on the date of 06.02.2018 pursuant to notification dated 08.12.2017 (Annexure-F).

5. Per contra, Smt. Vanaja, learned counsel for the 2nd respondent-BDA submits that 2nd respondent-BDA considering all the applications as required under Rule 7 of the 1989 Rules, allotment has been made to 3rd respondent. Further he submits that resolution itself states that all the applications were considered.

- 6. Sri. Jagadish Baliga, learned counsel would submit that pursuant to allotment of Civic Amenity site, the 3rd respondent has paid the entire amount demanded and submits that BDA on consideration of all the applications has allotted the Civic Amenity site in favour of 3rd respondent. As such he prays for dismissal of the writ petition.
- 7. On hearing the learned counsel for the parties and on perusal of the writ petition papers, the only point which arises for consideration in this writ petition is as to whether respondent No.2/BDA while allotting civic amenity site to 3rd respondent complied Rule 7 of 1989 Rules as well as direction issued by this Court in W.P.No.48202/2018 dated 06.12.2018.
- 8. Answer to the above point would be in the negative for the following reasons:

Both the petitioner and respondent No.3 had made applications for allotment of civic amenity site in pursuance of the notification dated 08.12.2017

(Annexure-E) in respect of civic amenity site No.10A of Sir.M.Visveswaraiah Layout, 2nd Block. The second respondent/BDA initially resolved to allot the civic amenity site in question in favour of 3nd respondent by its resolution dated 25.09.2018. The said resolution was the subject matter of the writ petition before this Court in W.P.No.48202/2018 disposed of on 06.12.2018. This Court, while disposing of the writ petition at paragraph 8 has observed as follows:

"8. As observed by this Court in the above decision, the B.D.A. ought to have bunched all applications for consideration on the basis of comparative merits keeping in view the Rule position. This exercise having not been done, the impugned allotment made in favour of 3rd respondent-Society is liable to be set at naught so that all the applications as on 06.02.2018 i.e., the earlier Resolution at Annexure-B was made, are all bunched and thereafter considered with their comparative merits, afresh."

In the above said order by the Co-ordinate Bench of this Court, reliance was placed on a decision of this Court reported in (1999)6 Kar.L.J 101 in the case of

VINEETH EDUCATION SOCIETY (R) BANGALORE v/s

BANGALORE DEVELOPMENT AUTHORITY,

BANGALORE AND ANOTHER.

9. A reading of the above order of this Court makes it clear that this Court had directed the second respondent/BDA specifically to bunch all the applications for consideration on the basis of comparative merit keeping in view Rule Position.

Rule 7 of 1989 Rules reads as follows:

- 7. Principles of selection of Institutions for leasing out Civic Amenity Sites:
- (1) The Authority shall consider the case of each institution on its merits and shall have special regard to the following principles in making the selection:-
- (a) The Objectives and activities of the institution and public cause served by it since its establishment.
- (b) The financial position of the institution;
- (c) The present location of the institution;

- (d) The benefit likely to accrue to the general public of the locality by allotment of the civic amenity site;
- (e) The bonafide and genuineness of the institution as made out in the annual reports, audit report etc.;
- (f) The need of the civic amenity site by the institution for providing the civic amenity in question.
- (2) For the purpose of sub-rule(1), the authority may constitute a separate committee to be called "Civic Amenity Site Allotment Committee" consisting of three official members and three non-official members,. The Chairman of the Authority shall be the Chairman of the Authority shall be the Chairman of the Civic Amenity site Allotment Committee.
- (3) Subject to the approval of the authority, the decision of the Civic Amenity Site Allotment Committee shall be final".

The above ruling requires the BDA to consider the criteria stated therein while selecting an Institution for allotment of civic amenity site. The criteria required to be examined are: The objectives and activities of the

Institution and public cause served by it since its establishment; financial position of the Institution; the present location of the Institution; the benefit likely to accrue to the general public of the locality by allotment of civic amenity site; the bonafide and genuineness of the Institution; and the need of the civic amenity site by the Institution for providing civic amenity in question. This Court had made it clear that BDA shall bunch all applications for consideration and to consider the same on the basis of comparative merits keeping in view the Rule position.

10. A perusal of the impugned resolution would not disclose consideration of applications on the basis of comparative merit. Mere stating that all the applications are considered would not be sufficient nor would comply the requirement of Rule 7 of 1989 Rules as well as direction of this Court in the earlier proceedings. Relevant portion of the resolution reads as follows:

"ಮಾನ್ಯ ಉಚ್ಛ ನ್ಯಾಯಾಲಯವು ರಿಟ್ ಅರ್ಜಿ ಸಂಖ್ಯೆ 48202/18 ರಲ್ಲಿ ದಿನಾಂಕ 25-9-2018 ರಂದು ನಾಗರಿಕ ಸೌಲಭ್ಯ ಹಂಚಿಕೆ ಸಮಿತಿ ಸಭೆಯ ತೀರ್ಮಾನವನ್ನು ಅನೂರ್ಜಿತಗೊಳಿಸಿ ದಿನಾಂಕ 6-12-2018 ಬಾಕಿಯಿರುವ ಎಲ್ಲಾ ಅರ್ಜಿಗಳನ್ನು ಪಟ್ಟಿ ಮಾಡಿ ನಿಯಮ ಕಲಿಸಲಾಗಿರುವ ಅವಕಾಶದಂತೆ ಪರಿಶೀಲಿಸುವಂತೆ ಮಾಡಿರುವ ಆದೇಶವನ್ನು ಸಭೆಯು ಗಮನಿಸಿತು. ಮಾನ್ಯ ಉಚ್ಛ ನ್ಯಾಯಾಲಯದ ಆದೇಶದಂತೆ ಎಲ್ಲಾ ಅರ್ಜಿಗಳನ್ನು ಕೂಲಂಕುಷವಾಗಿ ಮತ್ತೊಮ್ಮೆ ಪರಿಶೀಲಿಸಿದ ನಂತರ, ನಿಯಮ 7ರಡಿಯಲ್ಲಿ ಕಲ್ಪಿಸಲಾಗಿರುವ ಅವಕಾಶದಂತೆ ಸರ್ ಎಂ ವಿಶ್ವೇಶ್ವರಯ್ಯ ಬಡಾವಣೆ 2ನೇ ಬ್ಲಾಕ್ ನಲ್ಲಿನ 6,007.73 ಚ ಮೀ ವಿಸ್ತೀರ್ಣದ ಸಿ ಎ ನಿವೇಶನ ಸಂಖ್ಯೆ 10/ಎ ಅನ್ನು ಸರ್ ಎಂ ವಿಶ್ವೇಶ್ವರಯ್ಯನಗರ ಮುಂದುವರೆದ ಬಡಾವಣೆ 8ನೇ ಬ್ಲಾಕ್ ನಿವಾಸಿಗಳ ಕ್ಷೇಮಾಭಿವೃದ್ಧಿ ಸಂಘದವರ ಪರವಾಗಿ ಚಾಲ್ತಿಯಲ್ಲಿರುವ ನಾಗರಿಕ ಸೌಲಭ್ಯ ನಿವೇಶನ ಹಂಚಿಕೆ ದರವನ್ನು ವಿಧಿಸಿ 30 ವರ್ಷಗಳ ಗುತ್ತಿಗೆ ಆಧಾರದ ಮೇಲೆ ಸಾಮಾಜಿಕ ಮತ್ತು ಸಾಂಸ್ಕೃತಿಕ ಚಟುವಟಿಕೆಗಳನ್ನು ನಡೆಸುವ ಉದ್ದೇಶಕ್ಕಾಗಿ ಹಂಚಿಕೆ ಮಾಡಲು ನಿರ್ಣಯಿಸಲಾಯಿತು."

11. A careful reading of the above resolution would indicate as to how casually the second respondent/BDA has passed the resolution ignoring Rule Position as well as direction of this Court. To the statement of objection, Annexure-R1/Chart is enclosed giving

particulars of the applicants who had applied to the Civic Amenity site in question, which is said to have been considered by the BDA in the meeting in question. The resolution would not remotely suggest consideration of all applications on comparative merit, or it would not disclose the merit or reason on which the BDA allotted Civic Amenity site in favour of respondent No.3. Thus, viewed from any angle, the impugned resolution would not stand to reasons and the same is contrary to Rule 7 of 1989 Rules. Hence, the following order:

- (a) A writ of certiorari is issued quashing the resolution dated 15.12.2018 insofar as Sl.No.9, subject No.32/18 in respect of civic amenity site No.10A of Sir M.Visveswaraiah Layout, 2nd Block.
- (b) The second respondent/BDA is directed to reconsider all applications received in pursuance of notification dated 08.12.2017 (Annexure-E) in respect of civic amenity site No.10A of Sir M.Visveswaraiah Layout, 2nd Block on comparative merit and

in accordance with Rule 7 of 1989 Rules, within a period of three months from the date of receipt of a copy of this Court.

(c) This is a fit case, where the second respondent/BDA is liable to pay cost of Rs.25,000/- to the petitioner for ignoring direction of this Court while passing the impugned resolution dated 15.12.2018.

With the above, the writ petition is allowed.
