DySP suicide: Case against George, IPS officers quashed

Bengaluru: The high court on Wednesday quashed the order of the special court rejecting the B report submitted by the Central Bureau of Investigation (CBI) in connection with the suicide of deputy superintendent of police (DySP) MK Ganapathy.

Former minister KJ Ge-



orge and IPS officers Pronab Mohanty and AM Prasad had challenged the August 28, 2020 order of the trial court.

After rejecting the October 30, 2019 closure report, the trial court had summoned the trio. A directive was also issued for registering a case under IPC section 306 against all them for abetment to suicide.

The petitioners claimed the CBI had filed a closure report after a thorough probe and it had been mentioned that Ganapathy committed suicide because of family

'Review nod given to fell trees for Metro project'

The HC on Wednesday directed the committee of experts appointed by it to take a fresh look at the October 17 official memorandum granting permission for felling 40 trees located along the Namma Metro project alignment in east Bengaluru.

The court noted that this was necessary as most of the permission orders were somewhat identical in nature, though trees are of different species and located at various places. Till the completion of the exercise, no tree must be cut. The high court is hearing a PIL filed by Bangalore Environment Trust, seeking a direction to conduct tree census in the city, TNN

Court slams officer for making false statement

Bengaluru: Observing the provisions of the Disaster Management Act-2005 is not being implemented properly, the high court on Wednesday directed the government to come clean on the issue.

A division bench noted that right from the establishment of the Karnataka State Disaster Management Authority to district-level authorities, the implementation is lacking as necessary rules are not yet framed. The court took K Umapathi, joint secretary of the disaster management, stamps and registration department, to task for making a false statement to the court in November last year, claiming the rules are being amended from time to time.

"The officer of the disaster management department doesn't know the difference between rules and government orders. That itself is a disaster." the court said and asked him to submit explanation by the next hearing. TNN
