Twist in sex CD case: Activist drops plaint against Jarkiholi

Says Victim, He Were Treated Like Criminals



Bengaluru: In a dramatic turn of events, activist Dinesh Kallahalli, who last week petitioned police that then water resources minister Ramesh Jarkiholi, was

allegedly sexually exploiting a woman in return for a government job, withdrew his complaint on Sunday Jarkiholi resigned on moral grounds a day after the allegation was made.

Handing over a five-page letier to Cubbon Park police through legal counse! Kumar Patil, Kallahalli said he was



disappointed by statements of a few politicians and by the state's action of allegedly treating the victim and the messenger "like criminals".

Last week, Kallahalli met Bengaluru City police commissioner Kamal Pant and filed a complaint that Ramesh Jarkiholi had allegedly sexually exploited a woman by promising her a job in Karnataka Power Transmission Corporation.

Kallahalli had said he had received a CD about the incident from an unknown person seeking justice and was taking it up as he was a social activist.

'Govt planning law to protect oliticians from blackmail'

Bengaluru: The BS Yediyurappa government is planning a law to tackle attempts to blackmail public figures of start malicious campaigus against them, former mintster Ramesh Jarkiholi's brother and BJP MLA, Balachandra Jarkiholi, said on Sunday.

He told reporters that a draft of the law which would curb the propagation of defamatory information, had been prepared and the bill would be passed in the ongoing budget session. Health minister K Sudhakar had also said on Saturday that a new law was on the eards.

Ramesh quit as the water resources minister last week after an activist filed a complaint linking him to a sex-for-job scandal. An alleged video of Ramesh and a woman also surfaced. Ramesh de-nied wrongdoing and the activist. Dinosh Kallahaili, withdrew the complaint on Sunday.

"There is a big racket to blackmail politicians and public figures through honey traps. The objective is to bring disgrace to reputed families and individuals. The government plans to bring in a new law, the draft of which is ready, and it will be passed in the current legislature session itself," Balachandra claimed.

ctivist Dinesh Kallahalli's U-turn may not immediately resurrect the political fortunes of Ramesh Jarkiholi, and the former minister may have to bide time before rejoining the BS Yediyurappa cabinet. Sources say it's a long road back to the ministry as BJP has to approve of his re-induction, and the green light from Dalhi will not come until assembly elections to be held later this month and in April are over.

had been an attempt to honey-trap Ramesh and there were call records to prove it, and he described the purported clip as fake. "The video was uploaded on YouTube hours before Kallahalli released it. Seventeen servers were booked and Rs to cross to Rs 17 crore was spent on this. It is a political conspiracy hatched to unseat Ramesh and bring disgrace to our family," he claimed, adding that three teams were behind the plot and they promised the woman R.50 lakh and a job in Dubei.

He asked authorities to order a forensic examination of the video. apart from socking a CBI probe into the whole matter. He urged Ramesh to file a complaint. "I will meet him and persuade him to register a police complaint. If he does not want to file a case, I will do it." Balachandra said.

He believes conspirators may have misled Kallahalli. On his earlier plan to file a Rs 100-crere defamation suit against Kallahalli, Balachandra said he would consult lawyers. He thinks it is improbable that any BJP members were involved in the whole episode.

I handed over the complaint to police. My specific demand was that cops ascertain whether the woman was sexually exploited. But society launched a 'shoot the messenger' campaign targeting me and the victim. Former chief minister HD Kumaraswamy, without proof, said there was blackmail involving Rs 5 crore. BJP MLA Renukacharya stated this kind of women are a 'danger' to the country." Kallahalli's letter read.

wrongly on social media and some said I had built a house by blackmailing people... These judgements were passed without any investigation There were timeats from various people and a campaign to defame me was launched," he said.

Police sources said they have approached the legal team. "This is a one-of-its-kind incident we have come across in recent years. Kallahalli came to file a complaint and appeared for questioning to co-operate in the probe. On Sunday, he sent his letter withdrawing the case. It has become complex as he was not present physically. We might call him to record his statement. There was no FIR registered but only an investigation to ascertain whether the allegations were true," police sources said.

Kalahalli's lawyer Kumar Patil said. "I submitted a plea to withdraw the complaint. The police inspector may ask Kallahalli to appear before them to close the case. If required, he'll come

to the station.'

Asked whether there was political pressure to withdraw the case, he said, "Kallahalli is not one who succumbs to political pressure as he has faced it before as an activist. His purpose was to provide justice to the victim but what is going on social media has really bothered him and led him to withdraw the complaint."
