# BDA Chairman, Commissioner spar over land allotment

Bangalore Development Authority (BDA), which is already in the eye of the storm over allegations of multiple scams, is once again in the spotlight. BDA Chairman S.R. Vishwanath, a ruling party MLA, and Commissioner H.R. Mahadev had a public spat on Tuesday, making allegations and counterallegations and holding parallel press conferences.

The bone of contention appeared to be the allor-

ment of 12.5 acres of land to a housing cooperative society towards compensation of land acquired by BDA in 1977-78. While Mr. Vishwanath held a press meet claiming the allotment was illegal, the Commissioner defended the allotnient.

The trading of allegations between the duo indicated a breakdown of their working relationship. Chief Minister B.S. Yediyurappa, who also holds the charge of Bengaluru Development, had earlier held a meeting between the Chairman and the Commissioner to broker peace. "However, it did not help. He is expected to hold another such meeting," said a source.

Mr. Vishwanath, specking to mediapersons in the BDA Board Room, alleged that the Commissioner had not been giving him any of the files that he had requested despite directions from the Chief Minister to cooperate with him. litimates later, III. Mahadev addressed the media in his office, which is also in the same building, to comter the allegations levelled against him. "After taking charge, the Chairman wrote a letter to me asking for all files to be submitted to him. It is true I have not submitted all the files he has sought. The BDA Act, 1976 is very clear - the Commissioner is the chief executive of BDA and the Chairman has no executive powers," he said. He denied allegations of irregularities and said he has been fighting to unearth scams in the Authority.
