#### SC Move Comes As A Big Relief To Yediyurappa Govt

Bengaluru: The Supreme Court on Friday stayed the Karnataka high court order of December 4 stipulating BBMP polls for 198 wards and posted the next hearing on February 5.

The high court had directed the state election commission to ensure completion of the delimitation process within a month, and to announce the poll schedule within six weeks thereafter.

The SC move comes as a big relief for the BJP government which has sought deferment of the polls. Sources said the state government on Friday orally

Staying HC order, the SC posts matter for February 5, indicating BBMP polls will be further delayed. The corporation's term ended in Sept

They said it was done to ensure wider representation to marginalised sections of society which live in the city.

They also claimed that the state election commission (SEC) has no locus standi to challenge the amendment legislation; instead, it is duty-bound to implement legislation passed by the state legislature.

three-member Supreme Court bench headed by chief justice SA Bobde and comprising jetices AS Bopanna and V Ramasubramanian admitted the special leave petition filed by the Karnataka government challenging the order and issued notice to the SEC and the petitioners, including Abdul Wajid and M Shivaraj.

The SE C said the Delimitation Commission is yet to submit its recommendation for dividing the corporation into 243 wards and the exercise would take considerable time to complete.

BBMP's term expired on September 10, not due to inaction of the state but in view of the prevalent pandemic, the petitioners claimed. "It is disappointing that civic polls are being delayed but we will continue our fight in the Supreme Court," said Wajid.
