After nearly four hours of heated debate, the Kerala Assembly on Thursday rejected a motion moved by the Opposition seeking the removal of Speaker P. Sreeramakrishnan alleging his role in the diplomatic channel gold smuggling case and reckless expenditure in the various activities by the Legislature Secretariat.

Moving the motion soon after Question Hour, IUML legislator M. Ummer said the Speaker had denigrated his office and that the resolution was not for personal or political reasons or for casting aspersions on Mr. Sreeramakrishnan. It was to protect the dignity of the House.

tant private secretary was questioned by the Customs for nine hours. It is said that the Speaker will be questioned by the Central investigating agencies after the ongoing Assembly session. Will the dignity of the House and Chair go up if he is summoned?" Mr. Ummer asked.

Earlier, S. Sharma of the CPI(M) questioned the admissibility of the resolution citing precedence, rules and procedures as the allegations were solely based on media reports. After heated arguments between the Opposition and treasury benches, Deputy Speaker V. Sasi granted permission, ruling that he was not looking into the technicalities. The resolution was supported by UDF legislators and lone BJP legislator O. Kajagopal.
