te for filing nominations is September 30. Polling was scheduled for October 21 along with assembly polls in Maharashtra and Haryana.

After a bench of Justices NV Ramana, Sanjiv Khanna and Krishna Murari indicated it will not pass interim order on the plea of 17 disqualified MLAs and would pass the final order after hearing the matter, senior advocate Rakesh Dwivedi, appearing for EC, said he would then ask the poll panel to defer the election process.

The lawyers appearing for the disqualified MLAs, CLP leader Siddaramaiah and other respondents said they had no objection to the EC's proposal. In view of the EC's assurance, the court deferred the hearing to October 22.

# Will study SC order and then take appropriate steps: ECI

Ter studying the order of Athe Supreme Court and taking feedback from senior counsel, the ECI shall take immediate consequential steps in the matter concerning the scheduled bypoll," an EC statement said.

The disqualified MLAs had approached the SC seeking permission to contest elections and told the bench their disqualification by then Speaker KR Ramesh Kumar was illegal as they were not given sufficient time to respond to the notice and the order was

passed within three days while the rule gave one week's time.

Their plea was opposed by state chiefs of Congress and JD(S) which alleged that there was no illegality in the then Speaker's order. The disqualification of MLAs had eventually led to the fall of the Congress-JD(S) government.

Some of the MLAs had contended that Kumar's decision was an illegal, arbitrary and mala fide exercise of his powers under the 10th Schedule of the Constitution. They also questioned Kumar's decision to reject their resignations.
