

# FACILITIES TO EX-MEMBERS OF KARNATAKA LEGISLATURE

### FACILITIES TO EX-MEMBERS

#### PENSION:

A person who has served for a period of five years as a Member of Legislative Council or Legislative Assembly or partly as a Member of Legislative Assembly and partly as a Member of Legislative Council is entitled for pension at the rate of Rupees Forty Thousand per month for the remainder of his life.

Any person who has served for more than five years shall be entitled for an additional pension of rupees one thousand per month for every subsequent completed year and part of the year exceeding six month shall be treated as full year for calculating additional pension.

A person who was elected for the first time has been prevented from serving as such for five years on account of dissolution of the Legislative Assembly is also entitled for pension.

A person who was elected in a bye-election or is nominated as a Member in the middle of a term and was not able to serve the full term, shall also be entitled for pension.

A person who was elected for the first time resigns, shall also be entitled for pension.

#### RAILWAY/AIR TRAVELLING ALLOWANCE:

A pensioner for every financial year shall be entitled to a sum of rupees one lakh per annum payable twice a year in two equal installments in the month of April and October for the purpose of meeting travelling expenses either single or with companion in one or more journeys by air or railway in India.

#### **BUS TRAVELLING PASS:**

A pensioner shall be provided with one non transferable pass for him and his companion which shall entitle

them at any time to travel by road transport services of the Karnataka State Road Transport Corporation from the ordinary place of residence of such Member in Karnataka to any place in the State of Karnataka or outside the State to and fro in such class of accommodation therein, as may be prescribed.

#### **MEDICAL FACILITIES:**

Every Ex-Member who is in receipt of the pension shall be entitled to fixed medical allowance of rupees five thousand per month, subject to the condition that the said amount shall be deducted in the medical reimbursement claim, if any, during the said month.

A pensioner who incurs expenses for the medical attendance and treatment obtained by him and members of his family at any Hospital or Dispensary maintained by the State Government or in any Hospital or Dispensary notified by the Karnataka Legislature, shall be entitled for reimbursement of the expenses incurred therein. The

expenses shall be inclusive of the charges for accommodation at the place where such treatment is taken.

In respect of expenses incurred by a pensioner for the medical attendance and treatment obtained by him in any place other than in a Hospital or Dispensary maintained by the State Government and other than in a Hospital or Dispensary notified by the Karnataka Legislature, he shall be entitled for reimbursement of the expenses incurred to the same extent as in Government Hospital or Dispensary.

- 1: 'Member of family' means the husband or wife, dependant unmarried son up to 25 years of age, dependant unmarried daughter, mentally retarded children including handicapped children, father and mother and 'mother-in-law/ father-in-law in case of female Ex-Member of Legislature.
- 2. A pensioner shall be entitled for reimbursement up to Rs.1,00,000/-per ear once in his life time for hearing-aid, up to Rs.50,000/- for denture and up to Rs.10,000/- for root canal with cap.

#### **FAMILY PENSION:**

- (1) Where a Member dies before the expiry of his term or where a person eligible for pension dies, there shall be paid to his family, a family pension at the rate of fifty percent of pension admissible.
- (2) The family of the deceased person, who was a Member of the Legislative Council or the Legislative Assembly whether he was in receipt of pension or not shall be entitled for family pension.

#### **MEDICAL ALLOWANCE:**

A family pensioner shall be entitled for rupees two thousand five hundred per month as fixed medical allowance.
