Why should legislators attend this program?

India continues to grapple with delivering quality healthcare and education across its states. Most states fall short of the National Health Policy (2017) target of allocating 8% of their budget to health, as personnel shortages and limited coverage remain key concerns. States are estimated to spend 15% of their budget towards education. Despite this, gaps in learning outcomes, teacher shortages, and low enrolments in higher education persist.
