

In this workshop, experts will discuss these persisting issues, including challenges in power generation and transmission, sustainable management of water resources, emerging environmental policies and regulations, and the financing of disaster management.

These discussions will help participants engage effectively in the legislative process and contribute to shaping policies and regulations.
