

Why should legislators attend this program?

In India, Law and Justice institutions such as the police department, the judiciary, and prisons face challenges in performing their duties effectively. This is due to the xisting gaps like large pendency of cases in trial courts, absence of proper prison infrastructure, lack of manpower in state police forces, etc. Both central and state governments are reforming existing practices to tackle these issues.

In this workshop, experts will discuss these challenges, and institutional reforms related to law and justice. It will help participants understand the gaps in the current system, and gain valuable recommendations from the experts to resolve them.

These discussions will enable participants to engage more effectively in the legislative process.
