## Why should legislators attend this program?

Indian state legislators ensure the efficient allocation of public funds through the State Budget. They approve the State Budget containing expenditure commitment, taxation proposals, and borrowing requirements and later scrutinise their utilisation.

Some major trends in past state budgets include implementing cash transfer schemes for women, increasing states' expenditure on subsidies, and persisting high debt accumulation against the recommended FRBM limits.

The workshop will give all participating legislators a detailed understanding of State Finances, its trends, and the persisting issues in state budgets of the previous and upcoming financial year.

This two-day policy workshop does not require a participation fee. PRS will provide all reading materials.
