## KARNATAKA LEGISLATIVE COUNCIL SECRETARIAT

### NOTIFICATION

No. LCS/ADM-I/134/C&R/2003, Bangalore-560 001, Dated: 18.12.2003.

Whereas the draft of the Karnataka Legislative Council Secretariat (Recruitment and Conditions of Service) Rules, 2003 which the Special Board of Karnataka Legislative Council Secretariat proposes to make in exercise of the powers conferred by sub-section (1) of section 3 read with Section 8 of the Karnataka State Civil Services Act 1978 (Karnataka Act 14 of 1990) were published as required by clause (a) of sub-section (2) of the said Section in Notification No. LCS:ADM-1:134:C&R:2003, Dated: 26<sup>th</sup> September 2003 in Part IV-A of the Karnataka Gazette, Extra-ordinary dated 26.09.2003, inviting objections and suggestions from persons likely to be affected thereby within 15 days from the date of its publication;

Whereas the said Gazette was made available to the public on 26<sup>th</sup> September 2003.

Whereas the objections and suggestions received have been considered by the Special Board of the Karnataka Legislative Council Secretariat.

Now, therefore, in exercise of the powers conferred by Sub-section(1) of Section 3 read with Section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) read with the second proviso to the said sub-section, the Special Board of the Karnataka Legislative Council Secretariat hereby makes the following rules. viz.,

**1. Title and Commencement:-** (1) These rules may be called the Karnataka Legislative Council Secretariat (Recruitment and Conditions of Service) Rules, 2003.

(2) They shall come into force on the date of their publication in the Official Gazette.

**2. Definitions:-** In these rules, unless the context otherwise requires:-

- " COUNCIL" means the Karnataka Legislative Council;
- "Legislative Council" means the Legislative Council for the State of Karnataka;
- "Legislative Council Secretariat" means the Karnataka Legislative Council Secretariat specified in sub-rule(1) of Rule 3;
- "Chairman" means the Chairman of Karnataka Legislative Council and shall include the Deputy Chairman performing the duties of the office of the Chairman under Article 184(1) of the Constitution of India, when the office of the Chairman is vacant ;
- "Secretary" means the Secretary of the Karnataka Legislative Council Secretariat;
- "Schedule" means the Schedule appended to these rules;

- vi) "Board" means The Chairman, Legislative Council and the Secretary Legislative Council;  
 vii) "Special Board" means the Chief Minister, the Chairman, Legislative Council, the Speaker, Legislative Assembly, the Minister in-charge of Parliamentary Affairs and the Minister in charge of Finance. The meeting of the Special Board shall be presided over by the Chief Minister.

**3. Karnataka Legislative Council Secretariat:-** (1) There shall be a Secretariat for the Karnataka Legislative Council in the name of the "Karnataka Legislative Council Secretariat" which shall include the staff in the Legislators' Home and the personal staff of the Parliamentary Functionaries i.e., the Chairman, the Deputy Chairman, the Leader of Opposition in Legislative Council and the Government Chief whip in Legislative Council and shall consist of posts of Group A, B, C, and D of such number, categories and grades as are specified in Schedule I. The method of recruitment and the qualification for appointment to such posts shall also be as specified in Schedule-I.

**4. Creation of posts:-** i) The Special Board may create the posts of Secretary, Additional Secretary & Joint Secretary with the concurrence of the Finance Department;

ii) The Special Board may amend Schedule-I by increasing or reducing the number of posts specified therein or by adding thereto any new category of posts or in any other manner;

iii) No order creating a post shall be made under sub-rule (ii) except after consultation with the Finance Department;

iv) The Chairman may, without the approval of the Special Board, create the category of posts of Deputy Secretary and Under Secretary in Group-A and posts in Group-B, C and D with the concurrence of the Finance Department.

**5. Administration of Karnataka Legislative Council Secretariat:-**

- i) Subject to the provisions of these rules, the Chairman shall have control over the Staff and administration of the Karnataka Legislative Council Secretariat.
- ii) The Chairman may, delegate to the Secretary such of the powers for such time and subject to such conditions as may be specified in this behalf.
- iii) The Secretary may, delegate to his subordinate officers such of his powers and subject to such conditions, as may be specified in this behalf.

**6. Appointments:-**

- i) Appointment to the category of posts of Secretary, Additional Secretary and Joint Secretary shall be made by the Special Board. The method of recruitment in any particular case not provided for by rule 3 shall be determined by the Special Board.
- ii) Appointment to Group A posts other than the posts of Secretary, Additional Secretary, Joint Secretary, and post in Group 'B', 'C' and 'D' shall be made by the Chairman. The method of recruitment in any particular case, not provided for by Rule 3 shall be determined by the Chairman.
- iii) The Chairman may, redesignate or convert the posts of equivalent pay scale in the Schedule-I, up to the rank of Deputy Secretary in the interest of administration, whenever necessary, without incurring additional financial burden of the exchequer.
- iv) The Secretary may appoint three temporary stenographers to give Secretariat Assistance to the Members of the Legislative Council and Six temporary Lady Dalayats for attendance at the building provided for the accommodation of Lady members of the Legislative Council during the sessions of Legislative Council, two days before the Commencement and two days after the closure of the said Session.
- v) Notwithstanding anything contained in the preceding sub-rule for purpose of attending to the increased work in the Karnataka Legislative Council Secretariat during the Session of the Legislative Council, the Secretary shall be competent to appoint three temporary Typists and one Cycle Orderly 15 days before the commencement and two days after the closure of the Session in the grade fixed for such posts with the allowances admissible thereto.

- vi) The selection of candidates for appointment under these rules shall be subject to the provisions and for the time being in force, made by the State Government in relation to reservation of appointments or posts in favour of Schedule Castes, Scheduled Tribes and other Backward Classes of citizens and physically handicapped persons and Ex-servicemen.
- vii) Except as otherwise provided in these rules including the Schedule, it shall not be necessary to consult the Government on any matter, relating to the staff of the Karnataka Legislative Council Secretariat.
- viii) In case of the direct recruitment to any category of posts the Secretary with the approval of the Chairman shall invite applications from candidates possessing the prescribed qualification and select the candidates possessing the prescribed qualification most suitable for appointment after examination in writing or viva- voce or both, as the Chairman may deem fit.

Provided that vacancies may be filled up by the Chairman from the approved lists of candidates prepared in accordance with this sub-rule in which case there shall be no need to call for applications in respect of each such vacancy.

#### **7. Personal Establishment of Parliamentary functionaries:-**

i) The Personal Establishment of each of the Chairman Legislative Council and the Leader of Opposition, Legislative Council shall consist of the following staff, viz.,

ii) In addition to the above staff, the Personal Establishment of the Chairman shall consist of the post of Secretary to Chairman to be filled from among the Group 'A' Officers of the Karnataka Legislative Council Secretariat not below the rank of Deputy Secretary and one post of Officer on Special Duty to Chairman to be filled from among the officers of the rank of group 'B' and above. One post of Cook in Pay Scale Rs. 2500-3850 has also been created temporarily.

iii) The personal establishments of each of the Deputy Chairman Legislative Council and the Government Chief Whip of Legislative Council shall consist of the following viz.,

iv) The total period of appointment of any person under sub-rule (i), (ii) and (iii) shall be for a period co-terminus with the tenure of office of the Chairman. Legislative Council, the Deputy Chairman Legislative Council, the Leader of Opposition Legislative Council and the Government Chief Whip, Legislative Council.

v) Notwithstanding anything contained in these rules the Chairman may, if he considers it necessary for reasons to be recorded in writing, that it is in the public interest so to do, appoint to the category of posts in the personal establishment of the Chairman Legislative Council, the Deputy Chairman Legislative Council, the Leader of Opposition Legislative Council and the Government Chief Whip, Legislative Council, any person, other than retired Officer/Official of Government/Public undertakings who in his opinion, is able to discharge the duties of such posts on contract basis and on such terms and conditions as may be determined by agreement.

vi) Appointment under sub-rule (v) above may be made for a period co-terminus with the tenure of office of the Chairman, the Deputy Chairman, the Leader of Opposition, and the Government Chief Whip in Legislative Council.

vii) Notwithstanding anything contained in Rule 7(v) a person in the service of the Government or the Karnataka Legislative Council Secretariat shall not be eligible for appointment under the said sub-rule.

8. **Provisions relating to Disciplinary Proceedings:-** In respect of disciplinary matters, the provisions of the Karnataka Civil Services (Classification, Control and Appeal) Rules, 1957, for the time being in force, shall be applicable to the staff of the Karnataka Legislative Council Secretariat subject to the modifications specified in Schedule - II to the rules.

**9. Application of Rules in respect of matters not provided for in these rules:-**

Application of Rules made by the Government under the Karnataka State Civil Services Act 1978 and the deemed rules made under Sub-Section (3) of Section 3 of the said Act:-

- (a) The Karnataka Government Servant's (Seniority) Rules, 1957;
- (b) The Karnataka Government Servant's (Conduct) Rules, 1957
- (c) The Karnataka Civil Services Rules, 1958;
- (d) The Karnataka Financial Code, 1958;
- (e) The Manual of Contingent Expenditure, 1958;
- (f) The Karnataka Government Servant's (Medical Attendance) Rules, 1963;
- (g) The Karnataka Civil Services (Direct Recruitment) Rules, 1973;
- (h) The Karnataka Civil Services (General Recruitment) Rules, 1977;
- (i) The Karnataka Civil Services (Probation) Rules, 1977;
- (j) The Karnataka Civil Services (Performance Report) Rules, 1994;
- (k) The Karnataka Government Servant's (Compulsory Life Insurance) Rules, 1958;
- (l) The Karnataka State Employees Group Insurance Scheme Rules, 1981;
- (m) The Karnataka General Provident Fund Rules, 1957;
- (n) The Karnataka Departmental Enquiries (Enforcement of Attendance of witnesses and production of documents) Rules, 1981;
- (o) The Karnataka Civil Services (Classification, control and Appeal) Rules, 1957;
- (p) Karnataka Civil Services (Recruitment to Ministerial Posts) Rules, 1978; and
- (q) The Karnataka Civil Services (Typists & Junior Assistants/ Second Division Assistant) (Change of cadre) Rules, 1964.
- (r) The Karnataka Legislative Assembly Secretariat (Service and Kannada Language Examination) Rules, 1998;
- (s) Any other rules made by Government under the Karnataka State Civil Services Act, 1978 and the deemed rules made under Sub-section(3) of Section 3 of the said Act, shall apply to the Karnataka Legislative Council Secretariat staff appointed under these rules.

Provided that the Chairman may exercise the powers of the State Government under the provisions of the rules referred to in clauses (a) to (s), and Provided further that wherever relaxation of the above said rules is necessary it shall be made in consultation with the Finance Department or Department of Personnel and Administrative Reforms, as the case may be, wherever necessary and with the approval of the Chairman.

Provided also that a copy of every order made by the Chairman under the provisions of the above said rules shall be sent to the Secretary to Government in the Finance Department.



**10. Other Conditions of Service:-** The other conditions of Service of the Members of the staff of the Karnataka Legislative Council Secretariat shall, save as expressly otherwise provided for in these rules, be the same as those prescribed in respect of Government Servants holding corresponding posts in the Karnataka Government Secretariat.

**11. Procedure for taking decisions:-**

- i) Subject to these rules, on all matters having financial implications relating to the Karnataka Legislative Council Secretariat, the Secretary shall deal directly with the Secretary to Government, Finance Department.
- ii) The Chairman may, from time to time, by general or Special order, provide for the convenient and efficient transaction of business arising out of the administration of these rules and the procedure to be followed for the purpose.
- iii) No order having financial implications shall be issued without the approval of the Chairman or Special Board, as the case may be, and all proposals thereto shall be placed before the Chairman or Special Board, by the Secretary along with the remarks of the Finance Department.

**12. Vacancies in the Office of the Chairman and Deputy Chairman:-**

- i) In the event of a vacancy in the office of the Chairman or in the event of the Chairman being prevented from performing his duties, the Deputy Chairman acting as Chairman under Article 184(1) of the Constitution of India shall administer the Karnataka Legislative Council Secretariat and the powers and duties of the Chairman shall be exercised by him;
- ii) In the event of a vacancy both in the office of the Chairman and the Deputy Chairman, the person appointed by the Governor under Article 184(1) shall administer the Karnataka Legislative Council Secretariat and the powers and duties of the Chairman shall be exercised by him;
- iii) In the event of vacancies in the office of the Chairman and the Deputy Chairman or in the event of both of them being prevented from performing the duties, the Secretary shall, subject to the directions, if any, of the Governor, administer the Karnataka Legislative Council Secretariat; provided that any matter which requires approval of the Chairman shall be submitted to the Governor for decision; and provided further that any matter which requires approval or sanction of or consultation with the Chairman and which can without detriment to the public interest be deferred until a new Chairman or Deputy Chairman is chosen or until any one of them is capable of performing his duties, shall be deferred by the Secretary.

**13. Repeal and Savings:-** The Karnataka Legislative Council Secretariat (Recruitment and Conditions of Service) Rules, 1998 are hereby repealed; provided that any order issued, any appointment made, anything done or any action taken under the provision of any of the repealed rules shall be deemed to have been issued, made, done or taken under the provisions of these rules and shall, until altered or cancelled, continue to be in force.

The meeting of the Special Board shall be presided over by the Chairman, in the case of Legislative Council matters & by the Speaker in the case of Legislative Assembly matters.

### 4. Amendment to rule -4

**Creation of posts:-** i) The Special Board may create the posts of Principal Secretary, Secretary, Additional Secretary and Joint Secretary with the concurrence of the Finance Department.

### 5. Amendment to rule - 5

ii) The Chairman/Speaker may delegate to the Principal Secretary, Secretary such of the powers for such time and subject to such conditions as may be specified in this behalf.

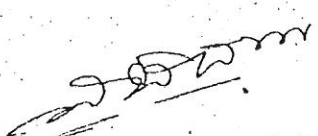

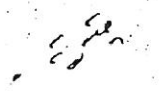

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 3 read with Section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) read with the second proviso to the said sub-section, the Karnataka Legislative Council Secretariat hereby makes the following rules.

#### 1. Title and Commencement:

(1) These rules may be called the Karnataka Legislative Council Secretariat (Recruitments and Conditions of service) (Amendment) Rules, 2009.

- (i) The Personal Establishment of The Chairman, the Deputy Chairman, the Leader of Opposition, the Government Chief whip, and the Opposition Chief whip in the Legislative Council ( hereinafter referred to as Parliamentary Functionaries) shall consist of the following staff and may be filled by deputation from any equivalent grade borne on the cadres of any of the State Civil Services, namely:

- (ii) In addition to the above staff, the Personal Establishment of the Chairman shall consist of;

(a) the post of Secretary to Chairman to be filled from among the Group "A" Officers of the Karnataka Legislative Council Secretariat not below the rank of Deputy Secretary

(b) One post of Officer on Special Duty to Chairman to be filled from among the Officers of the rank of Group B and above;

(c) One post of Cook.

(iii) Notwithstanding anything contained in these rules the Chairman may, if he considers it necessary for reasons to be recorded in writing, that it is in the public interest so to do, appoint to the category of posts in the personal establishment of the Parliamentary Functionaries, by any qualified person or retired Officer or Official of the Government or Public undertakings who is in his opinion, is able to discharge the duties of such posts on contract basis and on such terms and conditions as may be determined by agreement.

(iv) The total period of appointment of any person in the establishment of above Parliamentary Functionaries, under sub-rule (i), (ii) and (iii) shall be for a period coterminous with the tenure of office of the Parliamentary Functionaries in the Legislative Council.

- 1. Title and Commencement:** (1) These rules may be called the Karnataka Legislative Council Secretariat (Recruitments and Conditions of Service) (Sixth) (Amendment) Rules, 2011.
- (2) They shall come into force from the date of their publication in the Official Gazette.
- 2. Amendment of rule- 6:-** In rule 6 of the Karnataka Legislative Council Secretariat (Recruitments and Conditions of service) Rules 2003, (herein after referred to as the said rules), for clause (iv) and (v) following shall be substituted namely:-
  - (iv) The Secretary may appoint three Temporary Stenographers having the qualification for appointment of Stenographers under these rules along with Diploma in Basic Computers to provide Secretariat Assistance to the Members of Legislative Council, three temporary Typists & Two Cycle orderly to work during the Sessions of the Legislative Council. They could be appointed to work fifteen days before the date of commencement of the Session and their services shall be terminated two days after the closure of the said Session, with consolidated pay.
  - (v) The Secretary may appoint Six Temporary Dalayats during the Session two days before the commencement and two days after the closure of the said session, with consolidated pay, to attend to the works of Members of Legislative Council".
