

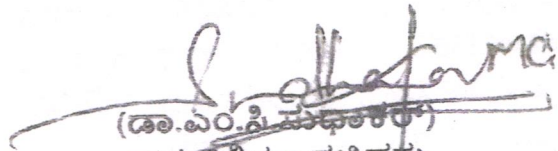

ORDER

This complaint has been filed by Ms.Spoorthy (sister of S.N.Bhavith Kumar) on behalf of her brother Mr.S N Bhavith Kumar who is studying 1st year B.Tech course in the respondent-Institution having been allotted seat through KEA under Government Quota during the academic year 2024 to 2025 and has paid a sum of Rs.750/- to KEA towards processing fee as per the Government Order as he belonged to Scheduled Caste. The complainant submits that at the time of admission, the respondent-CMR University has collected Rs.50,000/- towards part of the tuition fees which is contrary to the Government norms. Therefore, the complainant has filed a complaint seeking a direction to the respondent-Institution to refund a sum of Rs.50,000/- which is already paid contrary to Government norms.

2. The respondent-CMR University, on receipt of notice, appeared through its Administrative Manager and submitted that total fee payable by the student is Rs.1,27,495/- which includes University Registration fee, College fee and Rs.20,000/- towards skill lab fee as per the notification of the Karnataka Examination Authority for Engineering Programmes for the academic year 2024-25.

3. Today, the student – S.N.Bhavith Kumar along with his father Sri S.M.Nagaraja have filed an undertaking in favour of the respondent - CMR University stating that as they belong to Schedule Caste, they are entitled for

SSP Scholarship from the Department of Social Welfare, Government of Karnataka. They undertake to pay the entire SSP scholarship amount to the Institution as and when they receive scholarship amount from the Government and in the event of failing to pay the scholarship amount to the Institution within two weeks from the date of receiving the SSP amount, the Institution has got right to proceed in accordance with law including retaining of original marks cards of S.N.Bhavith Kumar, till the amount is paid. The said undertaking is placed on record.

4. Further, Administrative Manager of the respondent-CMR University has also filed an undertaking today stating that the student - S.N.Bhavith Kumar has paid Rs.50,000/- to them at the time of reporting to the college and they undertake to refund the said sum of Rs.50,000/- to the student in the form of Demand Draft. The said undertaking is placed on record.

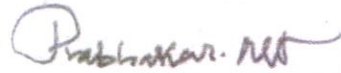
5. Today, as per the undertaking, Administrative Manager of the respondent-CMR University has handed over the Bankers Cheque No.700865 dated 28.02.2025 drawn in favour of S.N.Bhavith Kumar for a sum of Rs.50,000/- to Sri S.M.Nagaraja (father of the student) and Sri S.M.Nagaraja has acknowledged the receipt of the said Bankers Cheque.



In view of the above, the complaint stands disposed of.

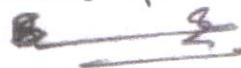
The Complainant -Ms. Syed Misba Noorain and her father are present.
On behalf of the respondent-Institution Dr.S.H.Shahapure, Chairman of MBA-HM of the Sharnbasva University is present.

2. The Chairman of the respondent-Institution fairly submits that while admitting the students into the MBA-HM of the Sharnbasva University during the academic year 2023-24, they have collected extra amount

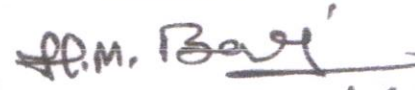
Rs.5,000/- with an undertaking to return or adjust this amount in the 2nd year fee. He has made it clear by stating that instead of collecting Rs.49,310/- as admission fee for 2nd Year MBA-HM, they would collect Rs.5,000/- less, that is, Rs.44,310/- after adjusting the Rs.5,000/- excess fee collected during the academic year 2023-24. He further submits that the respondent-institution has agreed to provide a letter regarding the fee to be paid by the complainant for the 2nd year as prescribed by Karnataka Examination Authority (KEA) so as to enable the complainant to apply for an educational loan from the Karnataka Minority Development Corporation (KMDC). His submissions are placed on record.

3. The Complainant submits that if the respondent-institution adjusts the excess fee of Rs.5,000/- collected during the academic year 2023-24 in the next year fee, as agreed by the respondent-Institution, she will be satisfied and will have no other grievance against the respondent institution and she prays for closure of the complaint. Her submission is placed on record.

In view of the above, the complaint stands disposed of.
