Vide your office reference letter dated 23-10-2019, it was mentioned that 05 circuits proposal vias submitted by Department of Tourism for the approval, but due to limited availability of the Funds under swadesh darshan Scheme, Ministry will not be able to sanction all the projects and will be restricting the number to one or two projects per state. It was further instructed that the proposal already submitted by the department are returned as they are not complete and not in line with the revised guidelines of the Swadesh the concept proposals which is in line with the scheme guidelines, recent schedule rates, employment generation, footfalls etc.

During the review meeting held under Chairmanship of Hon'ble Minister of Tourism, State Government of Karnataka to review the progress/present status of the proposal submitted to GoI, it was instructed by the Hon'ble Minister to submit the proposal to Ministry of Tourism, GoI for reconsidering all the projects submitted by the Department, as no projects are given approval and no funds were sanctioned by GoI for development of the Tourism in the state for past 04 years.

In view of the points narrated above, it is requested to kindly reconsider and to accord approval for all the above mentioned proposals already submitted by the Department of Tourism, GoK. If proposals are approved by Ministry of Tourism, GOI, Department of Tourism, GoK will restructure the DPRs in line with revised guidelines and schedule of rates.

Sri Chamundeshwari Devi Temple in Mysore is one of the most prominent temples and is a significant destination of international repute on the tourist map of India. It is a multifaceted destination offering numerous tourism products including religious, historical, cultural, adventure and eco-tourism. It is also considered as a "Shakti Peeth". The temple sprawls across a vast area and festivals like Mysore Dasara, Navratri and Ashada Shukravara are celebrated with great splendour at this temple. Countless devotees including domestic and international tourists visit this temple every day. The State festival - Mysuru Dasara starts with the worship of Goddess Chamundeshwari every year.

In consideration of these factors, it is reiterated that Sri Chamundeshwari Devi Temple in Mysuru is the most suitable pilgrimage destination that should be developed under the PRASHAD Scheme.
