



Hence, no transfer deed/ other instrument for transfer of shares are required to be submitted by its shareholder/s to the UPCL. Transfer takes place without intervention of UPCL.
2.	True Extract of the respective Board Resolutions approving acquisition by transfer of ownership attested by a Notary.	Copies of Board Resolutions of Corporate Shareholders of Lanco Group and Adani Power Limited for disposal/acquisition of shares in UPCL are enclosed herewith.
