Sub: Requesting to submit information on closure of production and job lost issue at Jaypes Cement, Shahabad Town, Kalaburagi District – reg.

With reference to your letter under Ref. we would like to submit few lines for your kind perusal.

## Preamble

Shahabad Cement Works was originally owned by ACC in 1930s, sold it out in 1989 to M/s. Fraser Investments Ltd. later on named as HMP Cements Ltd. HMP stopped operation of the plant on 7<sup>th</sup> December, 1997 and abandoned the unit under the provision of the recovery of debts due to the Banks and Financial Institutions Act 1993. The Debt Recovery Tribunal (DRT) auctioned the plant and machineries to recover their dues in 2005. Accordingly Zawar Cement Pvt. Ltd. (now name changed to Jaypee Cement Corporation Ltd) purchased the assets of the plant including Mines (ML-2092) in auction held by the DRT with a quantified liability as on 7<sup>th</sup> December, 1997 being the closure date, vide order dated 28.11.2006.

The project work started on 30.05.2012 after obtaining Consent for Establishment from the Karnataka State Pollution Control Board (KSPCB) Bangalore.

The 1<sup>st</sup> phase of the project consists of 2.4 mtpa Cement Grinding unit commissioned in March, 2015 and commercial production was carried out till November, 2015 by using Clinker from our Sister concern. Due to non viability and market recession cement production and dispatch stopped from April, 2016.

60 MW Captive Power Plant (CPP) was commissioned on 27.03.2015 and we had exported 40/50 MW to Power Company of Karnataka Ltd. (PCKL) through KPTCL from Sept. 2015 to May 2016. Due to lack of demand from State Grid and no production of Cement, the power generation was stopped from June, 2016.

Further construction activities of the 2<sup>nd</sup> phase of the project was stopped for want of Environment Clearance for Mines from MoEF&CC, New Delhi for which public hearings were held in 2009 & again 2012. Mutation of land registered in the name of Jaypee Cement Corporation Ltd. is pending at Tehsil Office Chittapur/Shahabad due to objection raised by GESCOM for clearing the old arrears of erstwhile HMP Cement. Banks/Financial Institutions are not coming forward to fund for the project due to pending mutation and Environmental Clearance for Mines.

- (a) We have already informed the concerned deptt. of Govt. of Karnataka regarding stoppage of production. No permanent labour lost employment due to stoppage of production. We have already obtained consent for operation of the plant from KSPCB Bangalore which is valid upto 30.06.2026.
- (b) As per DRT order 858 employees were on the roll of the Company (HMP) as on 7.12 1997 and all eligible employees had provided employment in 2007 and No body has been removed from their job. More than 90% of the employees have already retired from their service on attaining the age of 60 years. As on date 28 permanent employees and 43 persons on contract (including Security staff) are working. We are paying salaries and other benefits to these employees from time to time. We are regularly renewing the factory licence from time to time and is valid upto 31.12.2025.
- (c) No comments.

Jaypee Cement Corporation Ltd is **now under National Company Law Tribunal** (NCLT) from 22.07.2024 as per order No.CP (IB) NO.26/ALD/2023 with IA No.583/2023.
