Notification

Subject- Revision of Water and Sanitary Tariff – 2025

The last revision of water and sanitary tariffs by BWSSB was carried out on 01.11.2014. In the past 11 years, no revision has been made for both domestic and non-domestic retail water consumption. During this period, all components of the cost of water production, such as staff salaries, electricity charges, oil prices, consumables, etc., have more than doubled.

BWSSB is incurring high expenditures on power charges, operation and maintenance charges, and other miscellaneous expenses, which cannot be borne by the current revenue generated. the Board requested the Government of Karnataka on 29-01-2025 for a revision of water rates due to increased expenditures, and in response, a meeting was held with the Government on 28-02-2025.

A review meeting was held on 28-02-2025, chaired by the Hon'ble Deputy Chief Minister and Minister and in-charge of Bengaluru City Development, along with the Additional Chief Secretary-UDD, the Chief Commissioner of BBMP, and the Chairman of BWSSB. During the meeting, the following issues were discussed:

- Increase in Power Charges: Over the past 11 years, power tariffs have increased multiple times, leading to a significant rise in power costs for pumping water from TK Halli, operating water treatment plants, pumping stations, the recently commissioned CWSS Stage-V, and STPs. This surge in power costs has placed considerable pressure on BWSSB's operational budget.
- Higher Establishment Costs: The revision of pay scales has contributed to an increase in establishment costs over the past decade, further escalating BWSSB's financial burden.
- Rising Maintenance and Debt Servicing Costs: The continuous rise in infrastructure maintenance and debt servicing costs has exacerbated BWSSB's financial difficulties.
- Lack of Tariff Revision: BWSSB has not made any revisions to the water tariffs in the last 11 years, which has led to significant financial strain.
- The total financial deficit, which includes both cash and non-cash outflows, has been identified as a critical issue.

After discussions, the meeting concluded that the revision of water tariffs is essential, as no revision has been made in the last 11 years. The revised rates are designed to meet BWSSB's financial requirements to a significant extent while ensuring that the welfare of consumers, particularly those with lower domestic consumption, is not unduly burdened. Furthermore, it was decided to adopt the recommendation of the Karnataka Administrative Reforms Commission to implement a 3% annual increase in water tariffs, effective every 1st of April. In this regard, the Government of Karnataka, upon approval vide GO No. GO.UDD 33 MNI 2025(e) Dtd.02-04-2025, has directed BWSSB to implement the revised water tariffs at the Board level.

The subject was placed before the Board in its meeting held on 04-02-2025, highlighting all aspects of the revenue and expenditure of the Board and the dire necessity to increase the water tariff. Based on the decision of the Board and approval, this notification is being issued for the revision of water and sanitary rates for all consumer categories, as per Section 16 of the Bangalore Water Supply and Sewerage Act, 1964

10. Penalty

The existing penalty for not providing a Rainwater Harvesting system, non-submission of the Occupation Certificate, and not providing an STP remains the same for both domestic and non-domestic connections. However, for connections other than domestic and non-domestic, the charges are applicable at par with non-domestic connections.

The revised water and sanitation tariff will come into effect from 01-04-2025 in respect of all the consumers as per the rates shown above. The billing will be with effect from 01-05-2025.

As per the Karnataka Administrative Reforms Commission's recommendation, a 3% automatic annual increase in water tariffs every year 1st of April.

NOTIFICATION

Sub: Revision of BULK WATER TARIFF with respect to Apartments / flats, group housing, multi storied domestic building and Paying Guest W.E.F. 01.08.2025 and billing W.E.F. 01.09.2025.

The revision of water and sanitary rates for all consumer categories, as per Section 16 of the Bangalore Water Supply and Sewerage Act, 1964 came into effect from 01.04.2025 vide notification No. BWSSB/C/Tariff-2025/2024-25/292 dated: 9/4/2025.

In continuation to the revision of water tariff W.E.F 01.04.2025, the Bulk Consumers during the meeting held on 01.07.2025, many of the APARTMENT OWNERS ASSOCIATIONS / BANGALORE APARTMENT FEDERATION(BAF) expressed their willingness to rise in the WATER TARIFF after a decade but they also expressed the displeasure regarding the very high increase in WATER TARIFF for apartment irrespective of number of flats. The Apartment Owners Association / BAF informed that the present WATER TARIFF is based on the consumption only without taking into consideration the number of flats. The water consumption in case of lesser flats will be lower when compared to those apartments with higher no of flats. Hence the Apartment Owners Association / BAF requested to revise the WATER TARIFF based on the number of flats and by considering the minimum water consumption per flat.

Hence the subject with respect to "Revision of Water Tariff's for Apartments and PG proposed in the Revised Water Tariff W.E.F from 01.04.2025 and Billing W. E. F from 01.05.2025" was placed in the Board meeting held on 15.07.2025. Based on the decision of the Board and approval, this notification is being issued for the revision of Water Tariff with respect to Apartments and PG in continuation revision of water and sanitary tariffs 2025 implemented W.E.F 01.04.2025, as per Section 16 of the Bangalore Water Supply and Sewerage Act, 1964.

Revised BULK WATER TARIFF with respect to Apartments / flats, group housing, multi storied domestic building under DOMESTIC Category as per Clause 36(1) as detailed below:

- 1) To charge Rs.25/KL for water consumption ranging between 0 to 0.2 ML and Rs.28/KL for consumption ranging between 0.2 to 05 ML as per the present water tariff and having less than 200 flats as mentioned in the Table below:
