1.10	The State Government shall monitor compliance of conditions of Forest Clearance and shall submit in this regard yearly report as on 31st December of every year
1.11	Any other condition that the Ministry of Environment, Forest and Climate Change may stipulate from time to time in the interest of conservation, protection and development of Forest and Wildlife.
1.12	Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and action would be taken as prescribed under the Act. Rules and Guidelines relevant.
1.13	The State Govt. shall ensure that the complete compliance of FRA 2006 as per the rule 11 (7) of Van (Sanrakshan Evam Samvardhan) Rules 2023

3.3	The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost as per the directions of concerned Divisional Forest Officer.
3.4	All the funds received from the user agency under the project shall be transferred/ deposited to designated CAMPA account of the concerned State, only through e-portal (https://parivesh.nic.in/)
3.5	The State Govt./User Agency shall obtain necessary approval under applicable law/rules/orders including procedural/regulatory requirements under Eco Sensitive Zone.

The forest around Huland is home to diverse flora and fauna, and any disruption to its ecological integrity could have far-reaching consequences for wildlife, particularly tigers.

#### Assessment

BSNL has proposed to lay an optical fiber cable (OFC) along the road connecting Kankumbi to Huland, intended to link the tower at Huland constructed in non forest land. During discussions with BSNL officials it was found that the signal from the 4G tower at Chikle (which has already been recommended) located on the other side of a ravine separating Huland and Chikle settlements reaches the Huland tower by direct line of sight. This provides full coverage for the entire Huland hamlet and surrounding areas.

- Impact on Tiger Habitat: The laying of OFC cable in this area would introduce new infrastructure into a sensitive ecological zone. This could lead to habitat fragmentation, increased human activity, and potential disturbances to wildlife, particularly tigers, which rely on undisturbed corridors for movement.
- Limited Necessity: The proposed tower at Chikle, which has been recommended for approval, provides full coverage to Huland and connects wirelessly to the Tower constructed at Huland. The need for OFC to connect to the proposed tower at Huland and associated infrastructure is not justified.

In light of these considerations, the proposal for the laying of Optical Fiber Cable at Huland is not recommended.

A significant number of families residing in these villages have expressed their willingness to relocate under the Government of India's voluntary village relocation program. The forest department and district administration have identified priority sites, including Jamagaon, for this relocation process, which is crucial for the long-term conservation of the area.

#### Assessment

- Impact on Tiger Habitat: The laying of an OFC cable and erection of a new 4G Tower in this area would introduce new infrastructure into a sensitive ecological zone. It was noted during discussions with BSNL officials that while the signal from the existing tower at Hemmadga would cover certain areas of Degaon, it would not provide full coverage for the entire hamlet.

The forest department and district administration have identified priority sites, including Degaon, for this relocation process, which is crucial for the long-term conservation of the area.

#### Assessment

- Impact on Tiger Habitat: The erection of a 4G tower and the laying of an OFC cable in this area would introduce new infrastructure into a sensitive ecological zone. This could lead to habitat fragmentation, increased human activity, and potential disturbances to wildlife, particularly tigers, which rely on undisturbed corridors for movement.
- 2. Counterproductive to Relocation Efforts: The proposed developments may undermine the ongoing voluntary relocation efforts by making the area more

accessible and potentially more attractive for outsiders to settle in the hamlet. This is counter to the conservation goals that aim to reduce human-wildlife conflict and secure larger contiguous areas for wildlife.



In Gavali, there is a violation noticed where a 4G tower has been erected in Forest Land without taking necessary approval under the FCA.

The enhanced connectivity could indirectly support conservation efforts by improving communication system of forest department and facilitating more efficient management of the Bhimgad Wildlife Sanctuary.

### Impacts

The installation of the 4G tower is expected to have minimal direct effects on wildlife due to the non-intrusive nature of the tower and existing mitigation measures, such as road closure during night hours. Given the positioning of the tower outside critical habitat areas, no significant adverse impact on local wildlife is anticipated.

### Recommendation

The proposal aligns with the 4G Saturation Project of the Government of India, which aims to improve digital connectivity in underserved rural areas. ### Proposed Erection of a 4G Tower at Degaon Village within Bhimgad Wildlife Sanctuary

#### Overview

Degaon village is located approximately 6 kilometers from Hemmadga, accessible only by a road maintained by the forest department. This road traverses a pristine forest patch characterized by semi-evergreen and evergreen vegetation and is unpaved. The hamlet of Degaon consists of around 20 households with a population of approximately 100 individuals.

BSNL has proposed the erection of a 4G tower at Degaon, equipped with receiver and transmitter equipments, power generator and other necessary infrastructure. Additionally, there is a proposal to lay an optical fiber cable (OFC) along the road connecting Hemmadga to Degaon, intended to link with the tower. It was noted during discussions with BSNL officials that while the signal from the existing tower at Hemmadga would cover certain areas of Degaon, it would not provide full coverage for the entire hamlet.

### **Ecological Significance**

Degaon is situated within the Bhimgad Wildlife Sanctuary, a critical habitat that forms part of the larger Kali Tiger Conservation Unit. Bhimgad serves as a crucial corridor linking the Kali and Sahyadri Tiger Reserves, making it vital for tiger conservation. The sanctuary is home to diverse flora and fauna, and any disruption to its ecological integrity could have far-reaching consequences for wildlife, particularly tigers.

### Voluntary Village Relocation Efforts

Bhimgad Wildlife Sanctuary currently extends over 13 villages, including Degaon. A significant number of families residing in these villages have expressed their willingness to relocate under the Government of India's voluntary village relocation program. The forest department and district administration have identified priority sites, including Degaon, for this relocation process, which is crucial for the long-term conservation of the area.

### Assessment

- Impact on Tiger Habitat: The erection of a 4G tower and the laying of an OFC cable in this area would introduce new infrastructure into a sensitive ecological zone. This could lead to habitat fragmentation, increased human activity, and potential disturbances to wildlife, particularly tigers, which rely on undisturbed corridors for movement.
- 2. Counterproductive to Relocation Efforts: The proposed developments may undermine the ongoing voluntary relocation efforts by making the area more

accessible and potentially more attractive for outsiders to settle in the hamlet. This is counter to the conservation goals that aim to reduce human-wildlife conflict and secure larger contiguous areas for wildlife.

3. Limited Necessity: The proposed tower at Hemmadga provides partial coverage to Degaon. Given the ongoing relocation efforts and the limited population in the area, the need for a tower at Degaon and associated infrastructure is not justified.

Approving this project would be detrimental to the long-term conservation goals of the Kali Tiger Conservation Unit and could jeopardize ongoing efforts to preserve the ecological integrity of the Bhimgad Wildlife Sanctuary.
