

to a point about 7 chains south-west from north-west corner of S. No. 36 of Rangappanahalli; then south-west for about 24 chains through S. No. 18 of Nidagal to a point about 5 chains north-west from the north-east corner of S. No. 33 of Rangappanahalli; then north-west for about 21 chains through S. No. 18 of Nidagal to a point about 5 chains north-east from the north-east corner of S. No. 17 of Mummadisagara and thence north-west for about 15 chains through S. No. 15 of Nidagal to a point about 5 chains north-east from the north-west corner of S. No. 17 of Mummadisagara, and thence north-west for about 41 chains through S. No. 18 of Nidagal to a point about 5 chains north-east from the south-east corner of S. No. 5 of Mummadisagara.

*West*:—The line then runs north-west of about 13 chains through S. No. 18 of Nidagal to a point about 5 chains north-east from the north-east corner of S. No. 5 of Mummadisagara; then north-west for about 11 chains through S. No. 18 of Nidagal to the starting point.

The Government of His Highness the Maharaja of Mysore are pleased to declare, under the provisions of Section 17 of the Mysore Forest Legislation (XI of 1900) that from the 1st March 1921, the area, the boundaries of which are set forth in the Schedule annexed to this Notification shall be deemed to be a State Forest subject to the exercise of rights specified at foot thereof:—

## Schedule

Dist.	Taluk	approximate area	Name of Block	Boundaries
Bangalore	Bangalore	476 acres and 21 guntas or 74 square miles	Malligut Valley Extension	<p><i>Situation</i>. The block is situated about a mile distant from Yessanthapur Railway Station and lies to the west of Hobli Headquarters.</p> <p><i>North</i>.—Starting from a point on the common boundary between Jarakabande Kaval and Laggere about 13 chains south-east from the north-east corner of new survey No. 9 of Laggere the line runs south-east, north-east, south-east, and again north-east along the said common boundary to the trijunction bounds of the said two villages with Kethamasaranahalli.</p>

*East*.—Then the line runs south-east along the common boundary between Kethamasaranahalli and Laggere to the trijunction bounds of the said two villages with Baneguruvannahalli; then south-west along the common boundary between Laggere and Baneguruvannahalli to the southernmost corner of new survey No. 35.

*South*.—Then the line runs south-west along the common boundary between Laggere and Baneguruvannahalli to a point about 2 chains south-west from the easternmost corner of new survey No. 44.

*West*.—Then the line runs north-west along the eastern boundary of new survey No. 42 for about 13 chains to its northernmost corner; then south-west for about three chains along the eastern boundary of new survey No. 84 to a point on the left bank of a Jungle stream about 9 chains north-west from the westernmost corner of new survey No. 42; then north-west along the left bank of a Jungle stream through new Survey Nos. 84, 86, 88, 89 and skirting 90, and through survey Nos. 14, 11, 12 and 10 to the starting point.

## Remarks:—

The following rights of way are admitted within the block for use by men, cattle and carts in case of cart-tracks which are 12 feet in width for use by men and cattle in case of foot paths which are 6 feet in width throughout the year.

1. Foot path leading from Laggere village to Kethamasaranahalli it enters the forest on the southern boundary of the block at a point about 10 chains north-east from the south-west corner of new survey No. 40 and goes north-east for about 63 chains through new survey Nos. 89, 24, 16, 17, 18 and 19 and quits the forest in the eastern boundary of the block at a point about 4 chains south-east from the trijunction bounds of Jarakabande Kaval Kethamasaranahalli with Laggere.

2. Foot path leading from Laggere village to Bangalore, it enters the forest in the western boundary of the block at a point about 10 chains south-east from the north-west corner of the new Survey No. 85 and goes east and north-east for about 66 chains through new Survey Nos. 85, 26, 27, 31, and 33 and quits the forest in the eastern boundary of the block at a point about 4 chains south-west from the trijunction bounds of Laggere, Kethamasaranahalli with Baneguruvannahalli.

## BOUNDARIES.

**North.**—Starting from the tri-junction bonds between Thimmanahalli, Neeralgi and the block, the line runs east along the southern boundaries of Neeralgi and Malladevihalli till it meets the road from Banawana to Chikmagalur and then the line runs south-east up to the north-west corner of Survey No. 119 of Masale and then it runs south for 14 chains along the west side of Survey Nos. 119, 118, 117 and 116, till it meets the south-west corner of Survey No. 116 and then it runs east for 10 chains along the south side of Survey Nos. 116 and 115 till it meets the south-east corner of Survey No. 115 and then goes straight east for 3 chains till it meets Survey No. 109 of Masale and it runs south-east along the western boundary of Survey Nos. 109 and 108 till it meets the south-west corner of Survey No. 108 and then south for 20 chains till it meets the north-west corner of Survey No. 94 and it runs south for 2 chains, east for 6 chains, south for 2 chains, north-east for  $3\frac{1}{2}$  chains, north for 7 chains and east along the southern boundary of Kolagunda till it meets the tri-junction bonds between Kolagunda, Mavathanahalli and the block.
