



While notifying the land for acquisition the Land Acquisition Officer has not mentioned any hissa number, in the absence of non-mentioning hissa numbers the present gazette notification issued is not menitainable in law.

2. Objectors submit that they have entered into an agreement of sale agreeying to sell 1 acre 16 guntas of land with one Sri. D.M.Marismappa who is the managing partner of Bhagya Enterprise on 22-11-1984 at the rate of Rs. 78,000/- per acre. As on the date of agreement of sale the prevailing market value of the land at the rate of Rs.78,000/- per acre. The time stipulated in the agreement of sale dated 22-11-1984 is 9 months, the objectors have ready and willing to perform their part of contract as per the agreement of sale, since D.M.Marismappa is fail to perform his part of the contract as per the agreement of sale within the stipulated period, & the agreement of sale executed by the objectors has been cancelled by issuing legal notice to him. As on today there is no agreement of sale, on the strength of the agreement of sale said D.M.Marismappa has no right to ~~that~~ act. objectors have executed the power of attorney, the Irrevocable Power of Attorney obtained by D.M.Marismappa is not maintainable in law, since the objectors have never appeared before the notary and admitted the execution of the Irrevocable Power of Attorney and further they have not put their signatures to the registered maintained by the notary.

3. The objectors submit that the present market value of the land as on the date of preliminary notification is at Rs. 4,00,000/- per acre, they have got serious objections to acquire the land in question. Their family consists of ~~mixx~~ themselves, second and third objectors wifes, ~~2~~ sons and ~~2~~ daughters. They are doing agriculture as their main avocation except agriculture they have no other avocation and they have no other income from any sources. 
