Subject: Request to sanction AIIMS at Raichur, Karnataka.

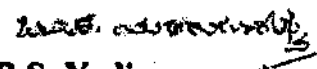
The experience in handling COVID 19 pandemic has underlined the need for setting up robust tertiary care hospitals in the most backward regions of the State. It is in this background that I request you to establish AIIMS like institute in Raichur District, Karnataka.

Raichur is a backward district located in the Hyderabad-Karnataka Region which has been given special status under Article 371J of the Constitution. It has also been identified by the Niti Ayog as an 'Aspirational district'. Raichur is a financially backward district having sizable population from the Scheduled Caste/Schedule Tribes and other backward classes. The district headquarter has a Government medical college with 500 beds and a 150 bed hospital which is under construction. Rajiv Gandhi Super specialty hospital with 250 beds is also functioning under Raichur Institute of Medical Sciences. Given the availability of basic medical infrastructure it would be possible to upgrade it to an AIIMS like institute with the assistance of the Central government. The establishment of the Institute would create better health infrastructure to the most backward region of Karnataka.

Hence, I once again request you to sanction AIIMS like institute in Raichur district of Karnataka.

Shri Mansukh Mandaviya Ji,

Government of Karnataka vide letter no: CM 360 GOI 2019, dated:21.09.2019 had sent a proposal to set up AIIMS at Hubli-Dharwad in the State in supersession of proposals submitted earlier considering the strategic advantages of the location.

Hubli-Dharwad is the second largest urban agglomeration in the State and is well connected to all other parts of the state. It has all the required necessary logistics including medical personnel and has reputed institutions functioning in the city. Establishing AIIMS here would make available affordable tertiary care to a large number of patients in the northern Karnataka region.

In this regard, in response to D.O no. Z_28016/107/2019_PMSSY received from the Health Ministry, GoI dated.19.02.2020, Government of Karnataka had submitted a detailed proposal in the prescribed format to the Ministry of Health and Family Welfare to set up AIIMS at Hubli-Dharwad vide letter no. HFW 137 MMC 2014, dated.21.09.2020. A central team from the Health Ministry has also visited the site on 02.12.2020 to assess the feasibility of the proposal and held discussions with the State Government officials. I understand that based on the report submitted by the central team the proposal has been sent to the Ministry of Finance for approval of the project.

It is requested to accord approval for the proposal at the earliest as setting up of AIIMS at Hubli-Dharwad will herald a new chapter in the health sector of northern Karnataka region.

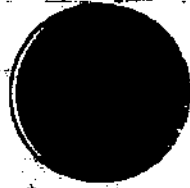

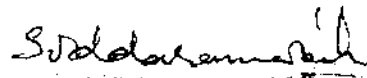
