## CONDITION OF AUTORICKSHAW CAB PERMIT

Permit No	
Vehicle No-	

- 1. That the vehicle relating to the permit shall be used only in the area/routes specified in the permit. BBMP limit
- 2. That no contract or hiring shall be entered in to by the Driver or permit holder outside the specified area or routes.
- 3. That no goods shall be carried the vehicle except passenger luggage, passenger effects of specified weight and passengers-luggage exceeds there for shall at the specified rate for such luggage as specified either inside the luggage —or outside luggage carriers.
- 4. That specified fares or fare shall be charged and a copy of the fare table approved by the -RTA shall be carried in every vehicle and also made available for inspection by passengers if so required.
- That passengers not more then be seating capacity assigned to both motor cab or auto rickshaw cab or specified in the permit relating to the vehicle shall be carried in the vehicle
- 6. That the motor cab/ auto rickshaw cab shall be fitted with the taxi meter or fare meter of the accredited type and approved by the RTA except otherwise exempted specifically and that such meter shall be maintainable in proper working order.
- That detention charges shall be charged according to the rates prescribed for the specified period.
- 8. That conditions as laid down under sec 84 of MV Act 1980 shall be strictly observed.
- 9. That the vehicles shall be parked at the stands approved by the RTA.
- 10. That no vehicles shall be replaced by any other vehicle except with permission of the RTA.
- 11. That no passengers, not included in the contract shall be picked up or set down along with the line/routes except those included in contract.
- 12. That the vehicle shall be kept ready always and make it available at Vidhana Soudha during office hours if specified agreed and undertakes in a condition precedent to grant of permit.
- 13. That by any reasons the driver, owner cause to drive the vehicle or the other removes from service of the present driver or paid drivers himself leaves his employment, the permit holder in all the aforesaid cases shall intimate the driver and particulars of licences and badge and his full name and address.
- 14. That the tax due in respect of the vehicle covered by the permit shall be paid accordance with the provisions of Karnataka Motor vehicle rules, and taxation Act and Rules.

- 15. That the permit relating to the vehicle shall always be carried in the vehicle and shall be produced before the authorised person.
- 16. The no goods liable to found that it is dangerous shall be carried in the vehicle.
- 17. That general merchandised goods shall be carried in the vehicle.
- 18. That no goods shall be placed on the right of the driver of the vehicle
- 19. That the change of address of the permit holder shall be intimated to the RTA which granted the permit.
- 20. That the vehicle shall be equipped with First Aid Box containing essential medicines prescribed in the MV Rules keeping it in a prominent place.
- 21. That the vehicle relating to the permit shall at all-time be furnished with one efficient jack and other tools, necessary to change the wheel or rim or type and with the equipment necessary to repair.
- 22. That the vehicle relating to the permit shall exhibit no advertisement devices, figures or printing specified the District Magistrate by general of specified orders.

## Additional Conditions w.e.f. December 2006 as recommended by the City Police Commissioner.

- 23. The driver shall comply with all the requirements under Rule 13 and 16 of KMV Rules 1989.
- 24. The driver shall not violate the provisions of the Rules of Road Regulations 1989.
- 25.Rule No120 of Central Motor vehicles Rules 1989 read with Section 56 of MV Act1988 shall be complied with
- 26. The driver shall not use adulterate fuel.

- 28. The driver shall comply with Rule 50 of CMV Rules 1989 (display of registration marks and number)
