PRECAUTIONS TAKEN BY THE KARNATAKA STATE INTEGRATED
CHILD PROTECTION SOCIETY, KSICPS TO PRVENT THE SPREAD OF THE
COVID-19

- 1. KSICPS has issued detailed Guidelines with regard to COVID-19 Precautions to be implemented in all the CCIs through Circulars dated: 18.03.2020 and 23.03.2020.
- COVID-19 Emergency Fund of Rs. 1.00 Lakh per district (Rs.2 lacs for Bengaluru Urban)was provided to meet the COVID-19 related expenses of the GovtHomes in the Districts vide order No: KSICPS/LEPAVI/-01/Ba vi Aa/31/2019-20 dated 19/03/2020.
- 3. Following the Supreme Court Directions in the Order dt: 23.03.2020 formed State Level COVID-19 Monitoring Team through Order No: KSICPS/COVID-19/1/2019-20 dated: 26.03.2020 to oversee the implementation of the COVID-19 related precautions in all the Child Care Institutions (CCIs). The Monitoring Team conducted detailed meetings on 27.03.2020, 07.04.2020 and 16.04.2020 to follow up the proper implementation of the COVID-19 Precautionary measures in all the CCIs.
- 4. DCPOs are working in Co-ordination with District administration to implement COVID precautions and necessary Steps are being taken including Fumigation of Homes. Directorate also issued specific directions with regard to regular Fumigation through letter dated 06.04.2020
- 5. Ensured that Lockdown Passes are issued to Child Line team in all the Districts to enableemergency child protection activities to take place without any interruption.

- 6. CWC's andJJBs are taking up urgent matters through Video Calls, Conference callsetc and issuing necessary orders.
- 7. We encouraged CCI staff to stay within the CCIs only where ever possible to avoid chances of infection due to staff travel.
- 8. ICPS Directorate has issued directions regarding purchase of Infrared Digital Non-contact Thermometer by the CCIs and at the level of each CCI itself to enable measuring the temperature of the children on a daily basis and maintain Register for the same through letter dated:09/04/2020.
- 9. As DCPU has only one vehicle and as it is difficult to supervise the implementation of the COVID precautions in all the CCIs across the District a request letter dated: 10.04.2020 was sent to Director, Women and child Development Dept to direct the Child Development Project Officers, CDPOs to cooperate and coordinate with the DCPOs in ensuring the Implementation of the COVID precautions in all the CCIs.
- 10. Apart from ensuring adequate Indoor play material, ICPS Directorate has issued directions to Conduct competitions among children to remove fear and anxiety created by the COVID-19 situation and to encourage the positive attitude and keep them engaged in creative activities so that they are mentally happy, healthy, positive in mind in this COVID-19 period through letter Dated: 11.04.2020. And presently these Competitions are going on.
- 11.As per the Supreme Court directions on 23.03.2020 and 03-04-2020, ICPS Directorate hastaken information of Children in Conflict with Law(CCL) Released and Residing in Observation Homes. According to this report 59 children have been released between 31.03.2020 and 22.04.2020 and 72

- children are residing in all 17 Observation Homes(OHs) and one Special Home and one Place of Safety as on 22.04.2020.
- 12.Like wise in case of Children in need of Care and Protection(CNCP) in 156 Govt funded CCIs 1906 Children went to Families in the month of March-2020 and later in the month of April-2020 338 children went back to Families and as on 18.05.2020 only 1595 children are staying in 125 CCIs and 357 children are staying in 31 SAAs.
- 13.To give special attention to the implementation of the COVID-19 Precautions in the Specialized Adoption Agencies(SAAs) that care 0 to 6 age group children a COVID-Core Committee for SAAs has been constituted exclusively through Directorate Order dt: 05.04.2020 involving retired Dept Officers and Experts in the Adoption issues.
- 14.To implement Hon'ble Supreme Court's Directions at Para 10 of the SuoMotu WP(C) No:4/2020 Dated: 03.04.2020 detailed Guidelines were issued to implement COVID-19 Precautions for the Children who are placed with Foster Care along with fixed Formats to submit the compliance with regard to the implementation of the COVID-19 precautions for the children in Foster Care through Directorate letter dated:16.04.2020
- 15.To implement the Hon'ble Supreme Court's Directions at Para 6(3) of the SuoMotu WP(C) No:4/2020 Dated: 03.04.2020 clear directions were issued that any dereliction of duty will attract serious punishments through Directorate letter dated: 08.04.2020
- 16.To keep regular watch about the COVID-19 related awareness sessions, medical check-ups, counseling sessions and Fumigations done in each CCI, a fixed Format was given to all the DCPOs to submit the details of the same

through the Directorate letter dated: 08.04.2020. Accordingly for the week of 11.04.2020 to 17.04.2020 it is reported that in all the 156 Govt funded CCIs around 300 awareness sessions, 263 medical ckeck-ups, 347 counselling sessions and 221 fumigation rounds were conducted.

- 17. Through Directorate letter dated 09.04.2020 directions were issued to all the DCPOs to caution the Private NGO run CCIs that if they do not cooperate with the District Child Protection Units(DCPUs) in implementing the COVID-19 precautions serious action will be taken against them.
- 18.To implement the Hon'ble Supreme Court's Directions at Para 4 of the SuoMotu WP(C) No:4/2020 Dated: 03.04.2020 detailed Guidelines were issued to all the Child Welfare Committees regarding how to ensure COVID precautions while implementing the Juvenile Justice Act,2015 provisions in the urgent child Protection cases through the Directorate letter dated:15.04.2020.
- 19.To keep monitoring the preparedness in terms of the Personal Protection Equipment Stocks a fixed Format was given to all the DCPOs to submit the Stock details of the Masks, Gloves, Sanitizers, Hand wash, Medicines stocked in the CCIs through the Directorate letter dated: 05.04.2020.
- 20.As per the Supreme Court Orders dt: 07.04.2020 and 13.04.2020 it is being monitored that DCPOs are ensuring that there are no problems for the transportation of the children who are being released from the Observation Homes/CCIs to reach their Native places.

- 21.To get the Health Status Report of all the Govt funded CCI children on a weekly basis one Directorate Officer was designated through the Directorate Order dated: 31.03.2020. According to these Reports till date there is NO COVID positive child in any of the CCIs.
- 22.DCPOs & DCPU members are visiting the CCIs regularly to ensure proper implementation of the COVID-19 precautionary measures. As per the Reports received in this regard from March 10th to April 20th all the 30 DCPOs put together did around 900 inspections of the 156 Govt funded CCIs and around 560 inspections of the Private CCIs. This includes repeated inspections to the same CCIs various times.
- 23. We have taken measures to keep the services of the Counsellors available to the CCI children continuously. 24.04.2020
- 24. We have taken measures to followup the children who went back to families minimum twice a week and to ensure counselling services available to kids as well as their parents. 25.04.2020
- 25.All DCPUs were made to download ArogyaSetu app
- 26.As there are 252 children in all the Open Shelters across the State as on 15.04.2020 we have initiated a special drive to produce these children before the CWCs so that they can reach their families as envisaged by the Hon'ble Supreme Court in its Orders dt:23.03.2020 and 13.04.2020
- 27. We have taken measures to give adequate ration to the Children while they are going to their parents so that there is no chance of malnourishment after going back to the family.

- 28. We are working in very close coordination with Child line and so far Child Line gave the information of needy children of the 1298 Migrant Families in 14 districts. And Child Line has confirmed that now food has been distributed to all the needy children of the Migrant families in all most all the areas.
- 29. We have taken measures to ensure that the children of our CCIs who now went back to families receive MDM ration in their native places only.
- 30. We are also taking measures to ensure that the benefits under Kishori scheme reach the eligible girls of CCIs who are now in their native places with their families.
- 31. We have taken measures to make the list of standby arrangement for all the Staff like Aayas, cooks etc ready so that in case any of the existing staff need to be Quarantined their responsibilities can be given to them readily. 24.04.2020
- 32. We have taken measures to arrange separate Fit Facilities for the rehabilitation of the newly rescued children so that there are no new entries to the existing CCIs. For this purpose as a first priority we have considered vacant CCIs and next we considered Social Welfare Hostels, BC welfare hostels, Education Dept Hostels etc as Fit Facilities.
- 33. On 02.05.2020 we have written to all the DCs who are the Chairpersons of the District Child Protection Unit, DCPU that as there is no uniformity in the building spaces of the CCIs it is necessary to take suitable decision about the Quarantine facility separately for boys and

- girls separately for CNCP and CICL children in consultation with the CWCs and JJBs at the District level itself. This letter helped the personal attention of the DCs on this issue.
- 34. On 03.05.2020 Order has been issued to all the CWCs to communicate them about the consequences of the violation of the Supreme Court's directions with regard to Online mode of business conducting by CWCs through SMWP (C) No. 4/2020.
- 35. On 05.05.2020 VC was conducted with all the DCPOs to review the implementation of the COVID-19 Precautions
- 36. On 09.05.2020 in the wake of Mumbai City Arthur Road Jail COVID-19 Positive cases incident all DDs, WCD were requested to direct their CDPOs to visit the CCIs within their jurisdiction to ensure the implementation of the COVID-19 Precautions and 18 Points check-list was given in this Letter for the said purpose.
- 37. On 16.05.2020 we have communicated to all the DCPOs that henceforth the information of all the registered CCIs in Karnataka should be part of the GOI Daily Reports about COVID Status as per the PAB directions on 14.05.2020
- 38. On 11.05.2020 we have sent a proposal to CARA to give permission to give COVID incentive of Rs.6000 per month for 3 months March, April and May 2020.
- 39. On 03.05.2020 an OM was passed regarding the COVID Precautions to be followed in all the Offices functioning under ICPS across the State.

- 40. On 04.05.2020 a communication was given to all the DCPOs to ensure that no child labour is used in APMC yards as per the instructions of the KSCPCR.
- 41. Through GO No: KSICPS/COVID-19/2020-21 dated:04.05.2020 Rs. 1500 for the months of April and May 2020 financial support was given to 2244 Children who went to Families from CCIs temporarily due to CIVID-19 to support their nutritional requirements during their stay at Families:

42. Working in close coordination and with the cooperation of the NGOs:

- A) As per the Supreme Court direction in Para 12 of the 03-04-2020 Order the Supreme Court order is translated into Kannada with the help of NGO friends and was sent to all the concerned in the Districts on 06-04-2020
- B)Enfold Pro Active Health Trust prepared detailed guidelines on "how" toimplement the Supreme Court order dated 03-04-2020 which is very helpful forthe practical purposes and submitted to UNICEF. Based on UNICEF recommendation guidelines prepared by Enfold proactive health trust to all CCIs were circulated to all the DCPOs on 06.04.2020
- C)Concern for Working Children, CWC plan for Child Protection in the field level both within and outside CCIs was also circulated to all the DCPUs on 24.04.2020
- D)GOI and UNICEF Cartoon stories giving awareness about COVID-19 were translated into Kannada with the help of NGO friends and were circulated to the Districts.

- E) With the help of Child Rights Trust we have issued Model Directory to be maintained in every CCI and all DCPUs.
- .F) Also with the help of the same NGO we have issued detailed Guidelines about the Preparation Strategy for protecting overall Child Protection aspects in the CCIs especially during this Pandemic Situation
- G) With the help of NIMHANS we have issued Guidelines regarding regular follow-up of the Children who have returned Home to ensure that COVID Precautions are being implemented in their families. Also we have taken measures to ensure necessary counseling facility to the Children and their Parents to provide pleasant atmosphere to the kids at their families.
- H) With inputs from UNICEF we have written to Home Dept to focus on the protection of street children during Lockdown and also to give awareness about Child Helpline 1098 and NIMHANS Tele counseling facilities.
- I) With inputs from BachpanBachaoAndolan we have written to Home Dept, Information Dept and Deputy Commissioners to fight against the Online Child Pornography and Child Abuses.
