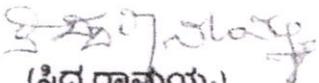

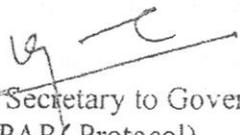

The rules and tariff for the occupation of Kumara Krupa Guest House New Building as indicated in the annexure are hereby issued. They will come into force with immediate effect.

**RULES AND TARIFF FOR THE OCCUPATION OF KUMARA  
KRUPA GUEST HOUSE NEW BUILDING**

The following Guest Houses are maintained by the State Hospitality Organisation, Bengaluru under the administrative control of the DPAR(State Protocol) of the State Government:-

- i. *Kumara Krupa Guest House, Bengaluru*
- ii. *Balabrooie VIP Guest House , Bengaluru*
- iii. *Government Guest House, Mysuru*

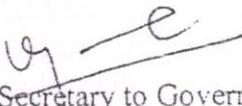
In addition to the above Guest Houses, a New Building consisting of 180 rooms is constructed as part of Kumara Krupa Guest House and the same is designated as Kumar Krupa Guest House New Building.

2. This KKGH (New Building) is primarily meant for the use of VIPs like the State Guests, Governor, Chief Minister, Ministers, Legislature Functionaries, Officers and Officials of the Karnataka State Government, the Government of India/Government of other States. The KKGH (New Building) is not open to the members of the General Public. However, subject to the availability, persons of known status other than those mentioned above, may be permitted to utilize accommodation and other facilities in this building by the Special Officer of State Hospitality Organization under special circumstances.

**Note:-** (i) *Deputy Secretary to Government, D.P.A.R.(State Protocol) may make or modify the allotment made by the Special Officer/Superintendent, Manager as above, when accommodation is required by the State Guests or other VIPs and any other emergent circumstances.*

(ii) *Government reserves the right to refuse accommodation to any person in public interest without assigning any reason, whatsoever.*

10. Children below three years will not be charged (if no separate bed is provided) ~~except for articles of food such as milk, biscuits etc. taken.~~
11. An inventory of furniture and all other articles kept in each room will be displayed prominently in the rooms. Guests are responsible for any losses, breakages or damage done by themselves or by their accompanied persons, to the building, the furniture, electrical fittings or other articles such as linen, crockery cutlery etc. and they shall make good the loss before they vacate the Guest House.
12. The Guests are requested not to utilize the services of the Guest Houses Staff for private work outside the premises, as they are intended only for work in Guest Houses.
13. All bills due to the Guest House should be settled in cash /online payment or through debit or credit cards before the guests vacate the building. It shall be the duty of the concerned Manger/ Official incharge of accommodation to recover the entire amount due from the Guests before they leave the Guest House.
14. The Boarding Tariff as fixed by DPAR (State Protocol) will be applicable for the guests except the state guest.
15. The Guests using telephone provided in the Guest House shall enter the required particulars in the register maintained for the purpose at the Reception counter and settle the bills before checking out. Local calls made by State Guests and the State Government Officers on duty, no charges shall be levied.
16. Persons against whom amount are outstanding in respect of boarding, lodging and transport charges of the Guest House, will not be provided with any facility in the Guest House unless the arrears are settled in full. The arrears if any from the Government employees will be recovered through the heads of their departments and for others, it will be recovered in accordance with Karnataka Land Revenue Act as an arrears.
17. Holding of meetings etc., in the premises of the Guest Houses for other than State Guest is prohibited.
18. The Chief Secretary to Government for sufficient and valid reasons, relax in writing any of these rules in any particular case.

~~Note: (i) Rooms in the KKGH (New Building) will be provided for the private visit of the Government officers/staffs subject to availability on those days (Tariff will be charged double the above mentioned rates). Preference will be given to persons, who are coming on official duty and if available, rooms will be provided for the private visit for a maximum of 3 days. If no. of the days exceeds 3 days, then for those extra days charges will be calculated on par with others.~~

(ii) *The Ministers of Karnataka State staying temporarily pending allotment of official residences (in case of exigency on approval by the Chief Secretary) will be charged at rate of Rs 2500/- per day per room in KKGH (New Building)*

(iii) *Boarding is optional.*

(iv) *Private cooking in the premises of a KKGH (New Building) is strictly prohibited.*

(v) *Officers accompanied by their family members shall pay the rates prescribed for Double Occupancy and additional members under the respective categories. "Family Members" for this purpose shall be husband or wife and wholly dependent children and parents of the Guest.*

(vi) *If the stay of any Guest (other than the State Guest) exceeds 5 days the tariff shall be double the charges applicable for the respective categories. If this stay exceeds 15 days, three times the normal charges shall be levied. Provided in case of Government servants on duty, they shall be charged at normal rates, if their stay beyond 5 days has been approved by the designated authority.*

7. The superintendent or The Manager of the Guest House concerned / any other appointed agency is authorised to collect advance lodging charges from all the guests at the time of checking in subject to giving cash receipts for the amount so received and setting off the same against final dues to be paid, when the Guest checks out.

8. A day is reckoned as 24 hours from time of arrival.

i. *Under this rule, Guests occupying the rooms even for very short periods have to pay full charges for lodging when once the rooms are occupied by them.*

ii. *Charges will also be levied for every additional occupancy of 24 hours or fractions thereof.*

9. *When a Guest occupies a double room exclusively for himself/herself and refuses to allow the Management to accommodate others therein, he/she will be made to pay full lodging charges applicable to two persons for double occupancy. The Guests shall always leave the room key with the reception on duty whenever they have to leave the Guest House. The Guest will have to pay double the prescribed lodging charges for the period wherein the rooms are booked by the Guests, though these rooms are occupied by them.*

- (i) *The application for advance reservation of accommodation in the KKGH (New Building) shall be addressed to the Deputy Secretary to Government, DPAR (State Protocol), Vidhana Soudha, Bengaluru-560 001, marking a copy to Special Officer, State Hospitality Organisation.*
- (ii) *The Application should be sent to the designated officer at least 7 days in advance. For valid reasons the applications may be entertained, if filed 3 days in advance subject to availability of accommodation. Any requisition submitted on the day of requirement of accommodation is normally not considered.*
- (iii) *Any accommodation reserved for a person other than a State Guest, Minister or other VIP or a Government servant on duty, is subject to cancellation of such reservation anytime. If the accommodation is already provided, it shall be vacated. If so required by the Manager or other higher officer of the Hospitality Organization.*

4. No person shall occupy the KKGH (New Building) for a period of more than 5 days without the previous permission of the Deputy Secretary to Government, DPAR (State Protocol). If the period of stay exceeds 15 days for any valid reason, permission of the Secretary to the Government, DPAR shall be obtained for period up to one month. If the period exceeds one month in exceptional circumstances, prior approval of the Chief Secretary shall be obtained.

5. A register will be kept at the KKGH (New Building) and it is mandatory that the Guests are required to note their names, address, contact telephone / mobile numbers, time of arrival and departure, whether their stay is official or private, indicate the advance charges paid and attest the entries with the signature.

New Tariff
