1) Introduction:

The Zilla Panchayat (ZP), Vijayapura is a body corporate constituted under the Karnataka Panchayat Raj Act, 1993 (Act) for overall supervision, co-ordination and integration of development schemes at taluk and district levels and for preparing development plan of the district. The monetary transactions of the ZP are routed mainly through a ZP Fund maintained in the District Treasury, Vijayapura. In May 2000, the Government instructed that monetary transactions relating to Centrally Sponsored/Central Sector Schemes not routed through the ZP Fund should also be accounted for suitably in the accounts of the ZPs. The audit of the accounts of the ZP Fund is entrusted to the Comptroller and Auditor General of India under Section 19(3) of the Comptroller and Auditor General's (Duties, Powers and Conditions of service) Act, 1971. The preparation of financial statements along with Bank Statement forming part of the accounts are the responsibility of the Zilla Panchayat. This draft Separate Audit Report contains the comments on the accounting treatment with regard to classification and compliance with the rules and regulations.

Comments on Accounts 3) Balances under Debit, Deposit and Remittance heads

3.1 The State Govt. vide circular no. RDPR/9/ARA/2008 dated 29.09.2009 have given detailed instructions to all ZPs regarding clearance of balances under DDR Heads and directed to clear the outstanding balances. However, the ZP Vijayapur has not taken any action to clear the outstanding balances under DDR heads even though it is being pointed out during previous SARs. 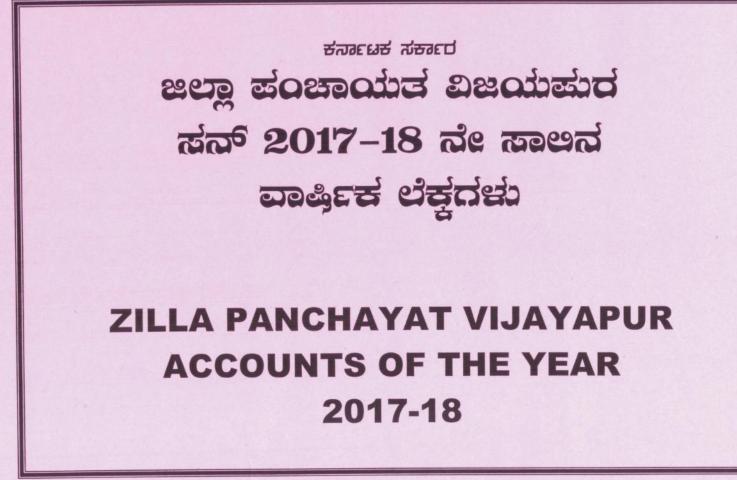
