### 1 Preamble:

Chamarajanagara Town is the Taluk and District Head Quarters of Chamarajanagara District. The Population of the Town is 69,959 as per 2011 Census. Chamarajanagara City Municipal Council is the Local body of the Town. This Town is located at a distance of 61km from the State Cultural City Mysore and at a distance of 180 km from the Capital city of Karnataka State Bengaluru. Bengaluru-Dindigul National Highway-209, Chamarajanagara-Jevergi National Highway-150A and Yalanduru-Gundlupete State Highway-81. Chamarajanagara-Biligiriranganabetta State Highway-80, is the Major Roads passing through the Town. Also the Town has good Broadgauge Railway Network. In this background We Develop the Town in systematic way. According to Karnataka Town and Country Planning Act 1961 section 4(c) The Government has been declared Local Planning Area for an area of 120.99 Sq.mtr. it includes Chamarajanagara Town and some parts of surrounding 27 villages. (Chamarajanagara, Channipuradamole, Ramasamudra, Karinanjanapura, Somavarapete, Galipura, Mudlupura, Mallayyanapura, Uttuvalli, Kadahalli, Masagapura, Managanahalli, Manchenahalli, Boodithittu, Mariyala, Gangavadi, Madapura, Doddamole, Kodimole, Haradanahalli, Bandigere, Yadapura, Shivapura, Chandakavadi, Kudluru, Basavanapura, Handrakalli) Asper Karnataka Development Authority Act, 1987 declare the Chamarajanagara-Ramasamudra Urban Development Authority and started functioning from dated:21-08-1998.

#### 1) Authority objectives:

As per Karnataka Town & Country Planning act 196I and Karnataka Urban Development Authority Act, 1987 in the Local Planning Area, providing technical opinion to the local bodies, technical approval to private layouts in the converted lands and to Ensure planned developments in its jurisdiction. In above, Development Authority collects the verification fees and statutory fees for sanction of plans and orders.

#### 2) Functions:

Development Authority in its jurisdiction, preparation of master plan and getting approval by the Government, revising the master plan, controlling developments as per the master plan and issuing technical approval to layouts and providing technical opinion to the revenue department for conversion of agricultural lands to non-agricultural purposes. Initiating housing schemes and distribute the sites to publics and control the different land use in Master plan is the main functions of the authority.

As per 2019-20, budget the expected income is Rs.13,30,20,000 and the actual income is Rs.78,55,798/-. But Rs.12,51,64,202/-would be shortfall than expected. The expected cost is Rs.12,03,82,000/- while the actual cost is Rs.19,09,509/-. The amount collected is less hence there is shortfull in expected income.

The lake development fee expected is Rs.50,00,000/- collected, Rs.10,26,250/-, Scrutiny fees Rs.4,00,000/- expected, but collected Rs.1,99,550/-, slum fees expected Rs.1,00,000/- collected, Rs.34,250/-, betterment fees expected Rs. 5,00,000/- collected Rs. 2,32,700/- only deposited. The collection is less than expected from other projects also. Even in the budget of the previous years, there is a dearth of reality than expected. It is

advised to prepare an budget to be closely to the actual income, expenditure (Budget enclosed).

The 50:50 Housing Scheme revenues and expenditures are included in the 2019-20 budget, resulting in a difference in expected revenues and expenditures that have not yet been approved by the government. Hence forth budget will be prepared to be closer to reality.

No information is available regarding preparation and submission of monthly accounts for verifying audit. As per KTCP Act 1961, sec 68(c) yearly accounts has to be submitted to the Senior Deputy Director, Local Audit circle, Chamarajanagara. The audit query number:03/2020-21, dated: 02.06.2020, stating that due to corona virus lockdown the accounts of the respective year will be submitted with the approval of the meeting. The audit for 2019-20 should be prepared and approval should be obtained and submit it immediately.

# 14) About the defect in cash book management:

The cash book shall be maintained as per Article-331 of the Karnataka Economic Code. The cash book is maintained in the office and not transacted according to the procedure

Cash book will be handled systematically as per the instructions.

At the end of the year the cash book closing balance with bank pass sheet should be checked.

The bank sometimes charges a bank charge. Such details are not taken into the cash book. Hence cash book details does not match with bank pass sheet.

Only the receipt number will be entered into the cash book without specifying the details. Hence it is not known towards what the receipt is received.

Audit Enquiry No: 06 / 2020-21, Date: 03.06.2020 was issued to rectify all the above shortcomings and to comply. Hence forth cash book should be maintained in a systematic manner.

## 15) Site distribution Application stock analysis :-

Chamarajanagara-Ramasamudra Urban Development Authority 2019-20 Audit is done. As per CA Site rule 1991, the CA sites applications distribution from No.0034 to 0100 totally 67 applications are remaining, which is tallying. No application form was issued in 2019-20.

# 16) Betterment Fees Payment:

As per Karnataka Town and Country Planning Act, 1961 section 18 out of the fee collected in the authority (KTCP fees)

5% has to be remitted through D.D to Karnataka State Town Planning Board, Bengaluru.

Out of the amount collected during 2019-20, 5% i.e Rs.11,635 is paid through cheque dated 02-09-2020 to Member Secretary, Karnataka State Town Planning Board, Bengaluru.

Every year through DD amount should be remitted. when checked on 31.03.2019, Rs.11,957/- has been paid in cheque No.610936, dated:13.01.2020.

In the year 2019-20, Rs. 2,32,700.00 as been collected out of that 5% has not been paid till the end of year 2019-20. Hence it should be remitted to Karnataka State Town Planning Board, Bangalore. So that the burden of debt will be less.

#### 17) Court Cases:

During the audit of the Chamarajanagar-Ramasamudra Urban Development Authority for the year 2019-20, A register has not been maintained for court cases. According to advocate A.V. Gangadharappa there are 7 cases pending in the Authority. Details are given in Annexure-03. Advocate A.V. Gangadharappa has received through cheque Rs.9000. Out of which 10% of income tax is deducted i.e Rs.1000/- and remitted to Income Tax Department.

# 18) Slum Improvement Cess Payment:-

As per Karnataka Slum Improvement Cess, Bengaluru letter No: PÀPÉÆCªÀÄ/É¥À±Á/PÉÆCPÀgÀ/2016-17/1746, Dated: 04.02.2017, in private layouts approved by urban development authority, Municipalities and others Local bodies slum improvement cess as to be collected.

During 2019-20 slum cess collected was Rs.34,250.00, out of that 70% means Rs.12,975/- as been sent to Commissioner, Karnataka Slum Development Board, Bengaluru. (cheque No:17792, Dated:16-09-2020)

During 2018-19 from chamarajanagar-Ramasamudra urban development authority Rs.17,700 as been collected towards slum improvement cess. Out of this 70% means, Rs.12,390.00 as been remitted to Commissioner Slum Development Board, Bengaluru. During 2019-20 Rs.34,250.00 as been collected towards slum improvement cess. Out of the fee collected 70% i.e Rs.23,975.00 as been remitted to Commissioner Slum Development Board, Bengaluru.

# 19) About TDS deduction from Fixed Deposit Investment (FDR):-

In Canara Bank Investment Account Number: 07970401002962/12 has been renewed. Out of Rs.57,617/- after renewal on dated:21-08-2019, Rs.4,147/- TDS is deducted. In Syndicate Bank Investment Account Number: 17004050029800, out of Rs. 3527787/- TDS deducted is Rs.46879, so total Rs. 51,026/- has been deducted. However, as per Rule 1961 of the Income Tax Rule 196, TDS should not be deducted from Government bodies.

It is instructed that TDS deduction of Rs.51,026/- should be taken back. Hence in audit letter No:02/2020-21, dated:02-06-2020 it is mentioned.

Investment tax liability deducted at the end of the investment period for 2019-20 should not be deducted from TDS on State-owned fixed deposits under Rule 196 of the Income Tax Act, 1961. Letter has been written to Manager, Canara Bank, Chamarajnagar, on:  $Z\acute{A}g\acute{A}\pm\grave{A}C$  $\acute{A}$  $\acute{A}$ 

Dated: 13-08-2020. During the discussion, Manager,

# 20) <u>Fixed Deposit Investments (FDR) renewal made</u> without following the Government Guidelines.

The Urban Development Authority (UDA) audit for the year 2019-2020 was carried out. If one crore exceeds the amount required to invest should be through e-bid and less than one crore should be through quotation. The FDR made was not in accordance with the guidelines in 2019-20. The audit query number:07/2020-21, dated:04.06.2020 states to provide appropriate details and as per circular action should be taken.

Before investing to avoid loss of interest to the authority above circular should be followed. Investment details are given in Annexure -4.

- 1) Fixed Deposit Investment in SBI Bank Rs. 2,50,95,015.00
- 2) Fixed Deposit Investment in Canara Bank Rs. 8,92,110.00

The fixed deposit has been renewed by the Urban Development Authority in 2019-20. The deposit is made at SBI, Canara Bank, Syndicate Bank Chamarajanagar. The investment amount is not one crore rupees. Investment will be made / renewed through quotation as per guidelines given in FD-38, TAR 2018 Dated: 27-08-2018.

# 21) Authority vehicle disposal:-

Chamarajanagara-Ramasamudra Urban Development Authority Vehicle No. KA-10 N-18 LMV Car ambassador is very old model. As per transport Commissioner, letter No., Á.DJ, i CAqi r. Dgi 251/96-97, Dated: 22-08-1996 the said vehicle is 14 years old hence the vehicle has to be disposed in the same condition and as per Government market value RTO has fixed Rs.68,000. Audit period 2018-19 stated to dispose, But so far not disposed. If the vehicle is depreciated by the end of the year, the Authority may suffer financial loss if the auction is not done by the RTO. The commissioner gave a verbal description of the issue and informed that the vehicle has been taken by DC office officials, including other department vehicles also. But there are no details on the vehicle disposal at the office.

It is advised to write a letter to Deputy Commissioner regarding vehicle disposal and take action for speedy bidding.

## 22) Staff Section:

The audit of 2019-20 of Chamarajanagar-Ramasamudra Urban Development Authority has been carried out. There are total 08 sanctioned posts in the office, 01 Commissioner post is filled while the remaining 07 posts vacant. 1] Twon Planning Members 2] Town Planners.

The Deputy Commissioner, Chamarajanagar District, will be requested to dispose of the vehicle in a speedy manner and auction the vehicle as soon as possible.

During the audit of 2019-20, Chamarajanagar-Ramasamudra Urban Development Authority, the salary details of the officers and staff are maintained in the prescribed format as per Article 09 of Article 52 of the Karnataka Economic Code. The payroll register will be produced.

The total amount of salary for the year 2019-2020 was Rs.450340/-. However, the salary of the office is not maintained in the prescribed format as per Article 09 of Article 52 of the Karnataka Code. The register is not properly managed. The clarification was sought in Audit Enquiry No: 05 and no reply was given. Therefore, it is recommended that the payroll be maintained in the prescribed format for further audit.

# 23) Hiring staff for office work on outsourced basis:

The audit of the Chamarajanagar-Ramasamudra Urban Development Authority for the year 2019-20 has been carried out with the recruitment of 05 persons on the basis of outsourcing for vacant posts.

Chittara Enterprises, which was awarded tender for 2018-19, till May 08 2019. From september-2019 the tender was awarded to Keonics Yuva.com. Under the Rules of 1999 of the USSR Act 1999, only the computer operator can be hired as per Rule 4 (G).

As in the authority there was vacant post so to do daily work from outsourcing agency during 2018-19 work order was awarded to Chittara Enterprises, Chamarajanagar till August - 2019. From September 2019 the tender has been awarded for the post of Office Assistant, Computer Operator, Driver and 'D'-group employees to Keonics Yuva.Com.

Government Order No: AE: 6: TPF 2018 Bangalore, dated: 22-03-2019 and Director of Town and Country Planning, Bangalore. Work order No: Nagroo / c (6) / ho.gov/2018-19, dated: 28-03-2019, from Karnataka State Electronic Development Corporation

Limited (AEOTI) to hire outsourcing service. Accordingly, outsourcing service is obtained by Keonics Yuva.Com.

The ESI and PF of these organizations have issued letters for payment. The challan, will be obtained. Therefore, Rs.1,55,576 can be omitted.

But it does not allow to hire office assistants, Driver, and D group employees. However, it has been suggested to clarify on that issue.

In the year 2019-2020, ESI & PF deductions copy of the Internet Generated Sheet attached to the relevant employee accounts is not produced. The agencies has not produced relevant information The audit query number 05/2020, dated 03.06.2020 to submit the amount of ESI and PF deposited to the employee accounts is not produced but below information obtained from the Chittara Enterprises is produced.

The advances paid from 2012-13 to 2017-18 was Rs.1,09,78,500/ - works not completed. These advance are related to bore well, bus stand construction, park development, master plan preparation and new authority building construction. When the above works are completed, the advance bill will be adjusted in the final bill and register will be maintained.

Audit Enquiry No: 11 / 2020-21, dated 04.06.2020 for advance from the year 2012-13, it was informed to clarify. The clarification on this is that the advance works not completed and the final bill is not paid. The commissioner said that the advance payment will be adjusted when the final bill is paid. Immediate action as to be taken.

#### 25) Construction of Authority office Building:

Construction of Chamarajanagara-Ramasamudra Urban Development Authority office building at No.301/1A, 302/2A, 32B/A 1B CA site was approved on dated 31-12-2015 for Rs.98,38,000.00. The work had to be completed and handed over as per agreement dated:07-10-2016 between authority and Executive Engineer, KRIDL Chamarajanagar within 18 months i.e., 15.03.2018. But there is no information on handing over building. So cheque no.566043, dated:07.10.16. far cheque Rs.49,19,000/and no.168737, dated:23.01.18 Rs.10,00,000/- total Rs.89,19,000/- has been paid.

There is no information on whether the work is completed and paid the remaining amount. Hence audit Enquiry No: 09/2020-21, dated 04.06.2020 to provide details. The Commissioner has clarified, so far Rs.89,19,000/- paid and pending payment is Rs.9,19,000/-. The final bill will be paid after deducting the penalty and for the work completed.

KRIDL, Chamarajanagar has been awarded to construct office of the Authority. The inauguration of the building was made in the presence of the Minister In Charge of the District on 08-01-2020. For KRIDL Chamarajanagar as per agreement Rs. 9,19,000 /- is pending. If there is any pending arrears from KRIDL in final pending bill it will be settled.

## 26) About Lake Development Fee Reservation: -

The Chamarajanagara-Ramasamudra Urban Development Authority development fee file has been verified 2018-19 collected amount was Rs.9,77,490.00. In 2019-20 amount collected was Rs.10,26,250.00. However, the audit found that the amount allocated was not used for the development of any lakes. The details of 2019-20 lake development fees enclosed in Annexure-05.

# 27) Layout approval for Residential/ Commercial/ Industrial uses:

Chamarajanagara-Ramasamudra Urban Development Authority has cleared 18 applications of residential/commercial/ Industrial in 2019-20 and details of applications are given in Annexure-06.

### 28) Change of Land Uses:

Approved 03 change of land use files in 2019-20 from Chamarajanagar-Ramasamudra Urban Development Authority. Details are given in Annexure-07.

Register about lake development fee is opened. Details such as opening balance, interest and expenses is showed. This will be produced in the next audit.

#### 29) Allocation of civic Amenities :

Applications for allotment of Civic Amenities was received in Chamarajanagar-Ramasamudra Urban Development Authority. For 5 institutions to construct Office Building in the year 2019-20, Rs.14,68,220/- has been collected as initial deposit of 10%. Details are given in Annexure-08.

## 30) CA Site lease amount interest payment :

The amount to be received by the Chamarajanagar-Ramasamudra Urban Development Authority for the year 2017-18 from Al-Jamiathul Saudia LilBanat was Rs.67,970/-was mentioned in the audit report of the year 2017-18. The interest rate of 18 per cent for 2018-19 was Rs.12,235/- to be collected. Also for the year 2019-20 Rs.67,970/- with an interest rate of 18% Rs.12,235/- to be collected. Audit enquiry No: 10 / 2020-21, Date: 04.06.2020 was issued. The details are as follows. Amount to be paid by Al-Jamiathul Saudia LilBanat:

# 31) Master Plan (Revision-II) Preparation is going on in a snail phase:

Chamarajanagar-Ramasamudra Urban Development Authority Master Plan (Revision-II) preparation was negotiated for Rs.12,40,000 in 2017-18. Contract agreement was made between STEM and Commissioner, Urban Development Authority (Contract No: M.P. (R-2) -1 / 2017-18 Date: 28.07.2017) Cheque No: 168694 dated 13.09.2017 was given during 2017-18 Rs. 168742, date: 07.03.2018 Rs.5,00,000/- was issued. Total Rs. 7,48,000/- has been paid, but Master Plan has not been submitted.

The deadline for making the Master Plan (revision-II) was on 28.02.2018. However, there is no record of any renewal of term limits by either the authority or the STEM. It is advised to get a master plan map and to penalize for the additional period.

#### 30) Audit Fees:

Chamarajanagara-Ramasamudra Urban Development Authority 2018-19 audit was carried out, as per Karnataka Urban Development Authority Act 1987 Sec 9(4) Audit fees has to be remitted. Rs.14,920/- for the year end 31.03.2019 is pending but this amount is paid on 06.12.2019.

In audit enquiry No: 08 / 2020-21 dated: 04.06.2020 the audit fees is calculated for the year 2019-20, Rs.16,504.00 which should be paid.

The Master Plan (Revision-II) preparation was awarded to STEM Agency, Bangalore. The maps were placed in the Authority Meeting dated: 19-06-2020 and submitted to Director, Town and Country Planning Department, Bengaluru on 01-07-2020. Hence the objection may be ignored.

This amount has been paid on 05.06.2020. So there is no pending of audit fees. The details are as follows.
