**THE BENGALURU METROPOLITAN LAND TRANSPORT AUTHORITY
(AMENDMENT) BILL, 2025**

(LA Bill No. 83 of 2025)

(As passed by the Karnataka Legislative Assembly)

A Bill to amend the Bengaluru Metropolitan Land Transport Authority Act, 2022.

Whereas it is expedient to amend the Bengaluru Metropolitan Land Transport Authority Act, 2022 (Karnataka Act 06 of 2023) for the purposes hereinafter appearing:

Be it enacted by the Karnataka State Legislature in the seventy sixth year of the Republic of India as follows, namely:-

1. Short title and commencement.- (1) This Act may be called the Bengaluru Metropolitan Land Transport Authority (Amendment) Act, 2025.

(2) It shall come into force at once.

2. Amendment of section 2.- In the Bengaluru Metropolitan Land Transport Authority Act, 2022 (Karnataka Act 06 of 2023) (herein after referred to as the Principal Act), in section 2, in clause (cc), for the words, brackets and figures “Bruhath Bengaluru Mahanagara Palike as defined in the Bruhat Bengaluru Mahanagara Palike Act, 2020” (Karnataka Act 53 of 2020), the words, brackets and figures “Greater Bengaluru Authority, as defined in the Greater Bengaluru Authority, 2024 (Karnataka Act 36 of 2025)” shall be substituted.

3. Amendment of section 4.- In the Principal Act, in section 4, in sub-section (1) in the table,-

(i) for clause (j) and the entries relating thereto, the following shall be substituted, namely:-

(j)	The Mayors of the City Corporations under the jurisdiction of the Greater Bengaluru Authority;	Ex-Officio Members

4. Amendment of section 12.- In the Principal Act, in section 12, in sub-section (1), in the table,-

(i) for clause (c), the following shall be substituted, namely:-

STATEMENT OF OBJECTS AND REASONS**(As appended to at the time of introduction)**

It is considered necessary to amend the Bengaluru Metropolitan Land Transport Authority Act, 2022 (Karnataka Act 06 of 2023) to revise the provisions of Constitution of Bengaluru Metropolitan Land Transport Authority and Executive Committee regarding Ex-officio Members,-

- (1) the Mayor, Bruhat Bengaluru Mahanagara Palike; and
- (2) Chief Commissioner of BBMP.

and to insert the City Corporations of Greater Bengaluru Area consequent on enactment of Greater Bengaluru Governance Act, 2024.

Hence, the Bill.

**EXTRACT FROM THE BENGALURU METROPOLITAN LAND TRANSPORT
AUTHORITY ACT, 2022**

(KARNATAKA ACT 06 OF 2023)

2. Definitions.- In this Act unless the context otherwise requires,-

(cc) “Urban Local Body” means and includes town panchayat and town or city municipal council as defined in the Karnataka Municipalities Act, 1964 (Karnataka Act 22 of 1964), and the City Corporation as defined in the Karnataka Municipal Corporations Act, 1976 (Karnataka Act 14 of 1977) and the Bruhat Bengaluru Mahanagara Palike as defined in the Bruhat Bengaluru Mahanagara Palike Act, 2020 (Karnataka Act 53 of 2020);

Constitution of the Bengaluru Metropolitan Land Transport Authority.- (1) The State Government shall, as soon as possible after the commencement of this Act, but not later than six months from the date of its commencement, by notification, establish an Authority to be called the Bengaluru Metropolitan Land Transport Authority consisting of the following members, namely:-
