ವಿಷಯ:

ಸ್ವಾತಂತ್ರ್ಯಪೂರ್ವ 1917 ರಲ್ಲಿ ಮೈಸೂರು ಮಹಾರಾಜ ಶ್ರೀನಾಲ್ವಡಿ ಕೃಷ್ಣರಾಜ ಒಡೆಯರ್ ಹಾಗೂ ಭಾರತರತ್ನ ಮೈಸೂರು ದಿವಾನರಾದ ಸರ್. ಎಂ. ವಿಶ್ವೇಶ್ವರಯ್ಯನವರಂತಹ ಗಣ್ಯರಿಂದ ಸ್ಥಾಪನೆಗೊಂಡಿರುವ ಹೆಮ್ಮೆಯ ದೇಶೀಯ ಸಂಚುರಿ ಕ್ಲಬ್ ಸ್ಥಾಪನೆಗೊಂಡಾಗ ಮಹಾರಾಜರಿಂದ 7 ಎಕರೆ 20 ಗುಂಟೆ ಜಮೀನು ದಾನವಾಗಿ ಪಡೆದಿತ್ತು. ತದನಂತರ ಸರ್ಕಾರಿ ಆದೇಶ ಸಂಖ್ಯೆ HCD 515 HGM 2014 Dated 05-11-2015 ರಲ್ಲಿ ಕಬ್ಬನ್ ಪಾರ್ಕ್ ನ ಉದ್ಯಾನವನ ವಲಯದಿಂದ 13 ಕಟ್ಟಡವನ್ನು ಕೈಬಿಟ್ಟು ಅಧಿಸೂಚಿಸಲಾಗಿದೆ. ಆದರೆ ಸದರಿ ಉದ್ಯಾನವನ ವ್ಯಾಪ್ತಿಯ ಒಳಗೆ (ಕಬ್ಬನ್ ಪಾರ್ಕ್, ಪ್ರಸ್ತುತ ಶ್ರೀಜಾಮರಾಜೇಂದ್ರ ಪಾರ್ಕ್) ಇರುವ ಸಂಚುರಿ ಕ್ಲಬ್ ಅನ್ನು ಪಾರ್ಕ್ ಜೋನ್‌ನಿಂದ ಕೈಬಿಟ್ಟಿರುವುದಿಲ್ಲ. ಇದರಿಂದಾಗಿ ಸಮಾಜಕ್ಕೆ ಬಹುಮುಖ ಕೆಲಸ ಗೈಯುತ್ತಿರುವ ಈ ಕ್ಲಬ್ ನ ಅಭಿವೃದ್ಧಿಗೆ, ಪುನಶ್ಚೇತನಕ್ಕೆ ಅಡಚಣೆ ಉಂಟಾಗಿರುತ್ತದೆ. ಹೀಗಾಗಿ ತ್ವರಿತವಾಗಿ ಸರ್ಕಾರವು ಸಂಚುರಿ ಕ್ಲಬ್ ನ್ನು ಪಾರ್ಕ್ ಜೋನ್‌ನಿಂದ ಕೈಬಿಡುವಂತೆ ಪ್ರಸ್ತಾಪಿಸಿರುವ ಬಗ್ಗೆ.



Correspondence ending with letter dated 23rd Nov. 1913, from the Secretary of the Cosmopolitan Club of Bangalore requesting the grant to them, free of cost, of a plot of land in the Cubbon Park for the construction of a building, the cost of which is estimated to cost Rs. 22,000/- and also for a financial contribution from Government on certain terms.

Order thereon No.G.3268-4/G.H.314-11-4(E.1) dated Bangalore, 27th October 1913.

The question of granting a site for the Cosmopolitan Club at Bangalore for constructing a building has been under consideration of the Government for some time past. The site in the Cubbon Park indicated in the accompanying sketch and measuring 7.5 acres (that is 7 acres and 20 guntas) in extent is, by reason of its central situation, most suitable and convenient to the people of both the city and the civil and military stations. The Government are therefore pleased to grant the site free of cost to the club, subject to the following conditions:-

- a. that suitable buildings are constructed thereon within a period of one year from the date of grant.
- b. that the plans of the proposed buildings are duly submitted and approved by Government.
- c. that, if the buildings ever ceased to be used for their present purpose, Government should have the option of purchasing them at a price to be fixed without allowing for the sites, and
- d. that the building shall in no case be disposed of without the sanction of Government.

As regards the contribution asked for towards the construction of the building, Government are not in favour of sanctioning any grant-in-aid for the purpose. But they will be prepared to advance, if necessary, a loan of Rs. 10,000/- without interest, the loan being repayable within five years and treated as a first charge on the building.

The above will be handed over to the Chief of
Administration of the plant and execution of the project by
agreement by the Board in accordance with the usual

NOTIFICATION

In exercise of the powers conferred by Sub-sections (1) and (2) of Section 3 of the Karnataka Government Parks (Preservation) Act 1975, (Karnataka Act 23 of 1975) read with section 21 of the General clauses Act, 1899 (Karnataka Act III of 1899) and in supersession of Government Notification No.AHD 138 HGM 97(i), dated 30th July 1998, the Government of Karnataka hereby specifies the boundary line for all the lands and buildings falling within the limits of the park known as Sri Chamarajendra Park (Cubbon Park) survey numbers as specified in schedule I and with limits of boundaries as specified in the schedule II, namely:-

 The Boundary shown in red colour in the map is the boundary of the Sri Chamarajendra Park (Cubbon Park) as described below:-

NORTH	The boundary starting from GPO circle running along Eastern side of Vidhan Veedi, Southern compound of GPO, Southern side of the building of Old Election Commission Office, Eastern side fence of Press Club(which is under lease by KGID), Eastern compound wall of Central Telegraph Office ending at King Edward Statue Circle. All along the fence on Western side of Queen's road starting from King Edward Statue upto Queen's Statue Circle(M.G Road Circle).
EAST	The boundary starting from Queen's Statue Circle along the Western side of Kasturaba road, North Eastern and Western side compound wall of Aquarium building, Western side compound wall of Police Department offices, Western side compound wall of Private Properties(Anderson Properties), Western side compound wall of Visvesvaraya Industrial Trade Center, Western side compound wall of Visvesvaraya Technological Museum, Western side compound wall of Government Museum and Western and Southern side compound wall of Venkatappa Art Gallery, then all along the Western side of Kasturaba road from Siddulingaiah Circle to Hudson Circle.
SOUTH	From Hudson Circle to all along the back side compound wall of Krishik Samaja building, back side compound wall of Chief Metropolitan Magistrate (CMM) Court.
SOUTH-WEST	From the back side compound wall of Police Department Offices, excluding YMCA building and its premises [which is part of Sri Chamarajendra Park (Cubbon Park)], there after back side compound wall of RBI, back side compound wall of YAVANIKA,

... compound wall of New Park Club (N.P.C.), Education, Excise, Treasury) up to compound wall of Survey Office at K R Circle, excluding Century Club and its premises (which is part of Sri Chamarajendra Park (Cubbon Park)).

All along the compound wall of BESSCOM building on Eastern side of Vidhan Veedi running upto the back side wall of GPO building, excluding the BESSCOM building with its compound and fence, Fisheries Canteen building, Priyadarshini Children's Library building and Karnataka Wine Board office building, NGO's building, KGS Club building, the High Court building and Old KOID building. (The open space between Fisheries Canteen building and Priyadarshini Children's Library, park area on South Eastern side of Priyadarshini Children's Library building, the KGS Tennis Court premises on the Southern side of KGS Club, the park area on the Western side of NGO's building and the garden area in front of High Court is part of Sri Chamarajendra Park (Cubbon Park), which is more clearly shown in the map prepared by City Survey Offices, Sketch showing details of Sri Chamarajendra Park (Cubbon Park) with existing buildings and road within as per spot, cadastral maps and records, and maps 300-2, 300-3 and 300-4 of the Survey Department, Bangalore, dated 07-09-2015 and the Survey Department (City) Bangalore, dated 07-09-2015.

The Sketch prepared by the City Survey Department vide 300-2 and 300-4, dated 07-09-2015 is attached to this notification and shall be deemed to be a part of this notification. Any disparities found between the boundary vis-a-vis the sketch, the sketch would prevail.
