ವಿಷಯ: "ಕರ್ನಾಟಕ ರಾಜ್ಯದ ಸರ್ಕಾರಿ ಕಾನೂನು ಕಾಲೇಜುಗಳಲ್ಲಿ 2022-23ನೇ ಶೈಕ್ಷಣಿಕ ಸಾಲಿನಲ್ಲಿ ಪ್ರವೇಶಾತಿ ಹೊಂದಿದ ಕಾನೂನು ವಿದ್ಯಾರ್ಥಿಗಳು ಮೊದಲನೇ ವರ್ಷದ ಕಾನೂನು ಪದವಿಯ 2 ಸೆಮಿಸ್ಟರ್‌ಗಳ ಪರೀಕ್ಷೆಗಳನ್ನು ಬರೆದಿದ್ದು, ಈ ಸಂಬಂಧ ಕರ್ನಾಟಕ ಕಾನೂನು ವಿಶ್ವವಿದ್ಯಾಲಯ, ಹುಬ್ಬಳ್ಳಿ ಇವರು ಪ್ರಕಟಿಸಿರುವುದು ಸರಿಯಷ್ಟೆ, ತದನಂತರ 2ನೇ ವರ್ಷದ ಕಾನೂನು ವ್ಯಾಸಂಗದ ಪರೀಕ್ಷೆಗಳನ್ನು ಏಪ್ರಿಲ್/ಮೇ 2024 ರಲ್ಲಿ ಬರೆದಿದ್ದು, ಫಲಿತಾಂಶವನ್ನು ಪ್ರಕಟಿಸದೇ ವಿದ್ಯಾರ್ಥಿಗಳ ಫಲಿತಾಂಶವನ್ನು ರಾಜ್ಯದ ಹಾಸನ, ಚಿಕ್ಕಮಗಳೂರು, ಶಿವಮೊಗ್ಗ, ಹಾಗೂ ಇತರೆ ಜಿಲ್ಲೆಗಳಲ್ಲಿ ತಡೆಹಿಡಿದಿರುವುದಾಗಿ ತಿಳಿದು ಬಂದಿರುತ್ತದೆ. ಈ ಕುರಿತಂತೆ ವಿಶ್ವವಿದ್ಯಾಲಯದ ಮಾಹಿತಿ ಪ್ರಕಾರ ಹೆಚ್ಚುವರಿ ವಿಭಾಗದ ವಿದ್ಯಾರ್ಥಿಗಳ ಪ್ರವೇಶಾತಿಗೆ ಕರ್ನಾಟಕ ಕಾನೂನು ವಿಶ್ವವಿದ್ಯಾಲಯದವರು ಹಾಗೂ ಸರ್ಕಾರದವರು ಮಾನ್ಯತೆ ನೀಡಿದ್ದು (BCI (Bar Council of India) ನವದೆಹಲಿ ಇವರಿಂದ ಹೆಚ್ಚುವರಿ ವಿಭಾಗಕ್ಕೆ ಮಾನ್ಯತೆ ಬಂದಿಲ್ಲವಾದ್ದರಿಂದ ಸದರಿ ವಿದ್ಯಾರ್ಥಿಗಳ ಫಲಿತಾಂಶ ತಡೆಹಿಡಿದಿರುವುದಾಗಿ ತಿಳಿದು ಬಂದಿರುತ್ತದೆ. ಈ ರೀತಿ ಫಲಿತಾಂಶವನ್ನು ತಡೆಹಿಡಿದಿರುವ ಕಾನೂನು ವಿಶ್ವವಿದ್ಯಾಲಯದ ಧೋರಣೆಯಿಂದ ವಿದ್ಯಾರ್ಥಿಗಳ ಭವಿಷ್ಯಕ್ಕೆ ತೊಂದರೆ ಉಂಟಾಗಿರುತ್ತದೆ. ಸದರಿ ವಿದ್ಯಾರ್ಥಿಗಳು ಹಳ್ಳಿ ಗ್ರಾಮೀಣ ಪ್ರದೇಶಗಳಿಂದ ಬಂದವರಾಗಿದ್ದು, ಎಲ್ಲರೂ ಆರ್ಥಿಕವಾಗಿ ಹಿಂದುಳಿದ ವರ್ಗ ಹಾಗೂ ಪರಿಶಿಷ್ಟ ಜಾತಿ ಮತ್ತು ಪರಿಶಿಷ್ಟ ಪಂಗಡಗಳ ವಿದ್ಯಾರ್ಥಿಗಳಾಗಿರುತ್ತಾರೆ. ಕಾನೂನು ವಿಶ್ವವಿದ್ಯಾಲಯದವರು 2ನೇ ವರ್ಷದ 3ನೇ ಸೆಮಿಸ್ಟರ್ ಬಿ.ಎ. ಎಲ್.ಎಲ್.ಬಿ ಪರೀಕ್ಷೆಗೆ ಸದರಿ ವಿದ್ಯಾರ್ಥಿಗಳಿಂದ ಪರೀಕ್ಷಾ ಶುಲ್ಕವನ್ನು ಕಟ್ಟಿಸಿಕೊಂಡು ಪರೀಕ್ಷೆ ಬರೆಯಲು ಅವಕಾಶವನ್ನು ನೀಡಿ ಪರೀಕ್ಷಾ ಫಲಿತಾಂಶವನ್ನು ತಡೆಹಿಡಿದಿರುವುದು ದುರಾದೃಷ್ಟಕರ ಸಂಗತಿ. BCI (Bar Council of India) ನವದೆಹಲಿ ಹೆಚ್ಚುವರಿ ವರ್ಗ ಅನುಮತಿ ಪಡೆದುಕೊಳ್ಳುವುದು ಆಯಾ ಕಾಲೇಜುಗಳ / ವಿಶ್ವವಿದ್ಯಾಲಯದ ಕರ್ತವ್ಯವಾಗಿರುತ್ತದೆ. ಈ ರೀತಿ ಅನುಮತಿ ಪಡೆದುಕೊಳ್ಳದೇ, ಬೇಕಾಬಿಟ್ಟೆ ವಿದ್ಯಾರ್ಥಿಗಳನ್ನು ಪ್ರವೇಶಾತಿ ಮಾಡಿಕೊಂಡು, ಶುಲ್ಕವನ್ನು ಪಡೆದು ಅವರುಗಳ ಪರೀಕ್ಷೆಯ ಫಲಿತಾಂಶವನ್ನು ತಡೆಹಿಡಿಯುವುದರಿಂದ ವಿದ್ಯಾರ್ಥಿಗಳ ಭವಿಷ್ಯದಲ್ಲಿ ಆಟ ಆಡಿದ ಹಾಗಿರುತ್ತದೆ. ಈ ಸಂಬಂಧ ಕೂಡಲೇ ಸರ್ಕಾರಿ ಕಾನೂನು ಕಾಲೇಜಿನ ವಿದ್ಯಾರ್ಥಿಗಳ ಹಾಗೂ ಚಿಕ್ಕಮಗಳೂರು ಶಾರದಾ ಕಾನೂನು ಕಾಲೇಜು ಮತ್ತು ಫಲಿತಾಂಶ ಬಾಕಿ ಇರಿಸಿಕೊಂಡಿರುವ ಇನ್ನಿತರೇ ಕಾಲೇಜುಗಳಲ್ಲಿನ ಕಾನೂನು ವಿದ್ಯಾರ್ಥಿಗಳ 2022-23ನೇ ಸಾಲಿನ ಫಲಿತಾಂಶವನ್ನು ಕೂಡಲೇ ನೀಡಿ, ಅವರ ಭವಿಷ್ಯಕ್ಕೆ ಅನುಕೂಲ ಮಾಡಿಕೊಡುವ ಸಂಬಂಧ ಮಾನ್ಯ ಕಾನೂನು ಮತ್ತು ಸಂಸದೀಯ ವ್ಯವಹಾರಗಳ ಸಚಿವರ ಬಳಿ ಪ್ರಸ್ತಾಪಿಸಬಯಸುತ್ತೇನೆ."

ಕರ್ನಾಟಕ ರಾಜ್ಯ ಕಾನೂನು ವಿಶ್ವವಿದ್ಯಾಲಯವು ಪ್ರತಿವರ್ಷ ಸಂಯೋಜನಾ ಅಧಿಸೂಚನೆಯನ್ನು ಹೊರಡಿಸುತ್ತದೆ. ಅದರಂತೆ ಹೊಸ ಕಾನೂನು ಮಹಾವಿದ್ಯಾಲಯಗಳು, ಹೊಸ ಕೋರ್ಸು ಹಾಗೂ ಹೊಸದಾಗಿ ಹೆಚ್ಚುವರಿ ವಿಭಾಗಕ್ಕೆ ಸಂಯೋಜನೆ ನೀಡಲು ಸ್ಥಾನಿಕ ವಿಚಾರಣಾ ಸಮಿತಿಗಳನ್ನು ರಚಿಸಿ ತಪಾಸಣೆ ನಡೆಸಲಾಗುತ್ತದೆ. ಸ್ಥಾನಿಕ ವಿಚಾರಣಾ ಸಮಿತಿಗಳು ಸಲ್ಲಿಸಿದ ವರದಿಗಳನ್ನು ಪ್ರಶ್ನಿಸಿ ಮಂಡಳಿ ಹಾಗೂ ಪ್ರಶಾಸನಾ ಸಭೆಯ ಮುಂದೆ ಮಂಡಿಸಿ ಶಿಫಾರಸ್ಸುಗೊಂಡ ಕಾನೂನು ಮಹಾವಿದ್ಯಾಲಯಗಳಿಗೆ ಸರ್ಕಾರದ ಅನುಮೋದನೆಗಾಗಿ ಪ್ರಸ್ತಾವನೆಯನ್ನು ವಿಶ್ವವಿದ್ಯಾಲಯವು ಸರ್ಕಾರಕ್ಕೆ ಸಲ್ಲಿಸುತ್ತದೆ.

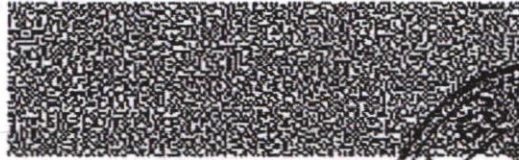

1. That the college had applied for the additional section for 3 year LL.B. programme for the academic year 2022-2023.

2. That the Local Inspection Committee of the Karnataka State Law University, Hubballi after conducting the physical inspection of the college had recommended for the grant of affiliation to additional section with an intake of 60 students.

3. That the affiliation to the additional section with an intake of 60 students was recommended by the Local Inspection Committee of the University subject to obtaining approval from Bar Council of India.

4. That the University vide its affiliation order no. KSLU/Acad/Affln/2022-23/2195 dated 17/02/2023 had notified the affiliation to additional section with an intake of 60 students. However, it was also made clear that the college should not admit the students to this additional section until Bar Council of India grants the approval for the affiliation granted to the additional section.

5. That despite the fact that the University had not given permission to the college to admit the students to the additional section till the college obtains approval from Bar Council of India, the college has admitted the students to the additional section of 3 year LL.B. Programme at its own risk.

6. That the college and management are aware of the fact that the admission of the students to the additional section is done in violation of the University's directions and BCI's Rules of Legal Education, 2008.

7. That the college and management are aware of the fact that the University is lawful in its decision of not approving the admission of the students who are admitted to additional section for which there is no approval of Bar Council of India.

8.
