Sub: Participation of Shri G Murali Krishna, Officer on Special Duty to Hon'ble Chairman in the 69th Commonwealth Parliamentary Conference scheduled to be held at Cape Town, South Africa from 13th to 19th September, 2026

READ:

PREAMBLE:

Hon. R Mtshweni Tsipane, MP, Chairperson of the National Council of Provinces, Parliament of the Republic of South Africa and Hon. A T Didiza, MP, Speaker of the National Assembly have sent an invitation to the Commonwealth Parliamentary Association, Karnataka Branch read at (1) above, requesting to send a Delegate / Observer / SOCATT / Accompanying Persons to attend the 69th Commonwealth Parliamentary Conference scheduled to be held in Cape Town, South Africa from 13th to 19th September, 2026.

Subsequently, Hon'ble Chairman of Karnataka Legislative Council has sent a letter read at (2) above stating that he would be attending the 69th Commonwealth Parliamentary Conference and would also undertake Post Conference Study Tour to Switzerland, Austria and France along with his spouse Smt. Asma Ahmed. Apart from this, he has stated that his O.S.D Sri **G Murali Krishna** would also be attending the 69th Commonwealth Parliamentary Conference and Post Conference Study Tour to assist him.

Accordingly, a proposal was sent to the Special Board seeking approval for participation of **Shri Saleeem Ahmed, Hon'ble Chairman, Karnataka Legislative Council, Smt. Asma Ahmed, Spouse of Hon'ble Chairman and Sri G. 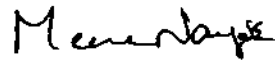
